**AN ACT**

To appropriate money to the Board of Fund Commissioners for the cost of issuing and processing State Water Pollution Control Bonds, Stormwater Control Bonds, Third State Building Bonds and Fourth State Building Bonds, as provided by law, to include payments from the Water Pollution Control Bond and Interest Fund, Stormwater Control Bond and Interest Fund, Third State Building Bond Interest and Sinking Fund, Fourth State Building Bond and Interest Fund, Water Pollution Control Fund and Stormwater Control Fund, and to transfer money among certain funds for the period beginning July 1, 2002 and ending June 30, 2003.

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

There is appropriated out of the State Treasury, to be expended only as provided in  
2 Article IV, Section 28, of the Constitution of Missouri for the purpose of funding each  
3 Department, Division, agency, and program enumerated in each section for the item or items  
4 stated, and for no other purpose whatsoever chargeable to the fund designated for the period  
5 beginning July 1, 2002 and ending June 30, 2003, as follows:

Section 1.025. There is transferred out of the State Treasury, chargeable  
 2 to the General Revenue Fund, Eighteen Million, Five Hundred  
 3 Eighty-Eight Thousand, Eight Hundred Twenty-One to the Fourth  
 4 State Building Bond and Interest Fund for currently outstanding  
 5 general obligations

- 6 From General Revenue Fund ..... \$18,588,821

Section 1.030. To the Board of Fund Commissioners

- 2 For payment of interest and sinking fund requirements on Fourth State
- 3 Building Bonds currently outstanding as provided by law
- 4 From Fourth State Building Bond and Interest Fund ..... \$18,709,008

Section 1.035. There is transferred out of the State Treasury, chargeable  
 2 to the General Revenue Fund, Thirty-Six Million, Seven Hundred  
 3 Thirty-Three Thousand, Five Hundred Forty Dollars to the Water  
 4 Pollution Control Bond and Interest Fund for currently outstanding  
 5 general obligations

- 6 From General Revenue Fund ..... \$36,733,540

Section 1.040. To the Board of Fund Commissioners

- 2 For payment of interest and sinking fund requirements on water pollution
- 3 control bonds currently outstanding as provided by law
- 4 From Water Pollution Control Bond and Interest Fund ..... \$36,609,988

Section 1.045. There is transferred out of the State Treasury, chargeable  
 2 to the General Revenue Fund, Three Million, Four Hundred  
 3 Ninety-Five Thousand, Seven Hundred Seventy-Two Dollars to  
 4 the Stormwater Control Bond and Interest Fund for currently

5           outstanding general obligations  
 6 From General Revenue Fund ..... \$3,495,772

Section 1.050. To the Board of Fund Commissioners

2 For payment of interest and sinking fund requirements on stormwater  
 3           control bonds to be outstanding as provided by law  
 4 From Stormwater Control Bond and Interest Fund ..... \$3,513,362

 4           State Building Bond Interest and Sinking Fund for currently  
 5           outstanding general obligations
