AN ACT

To amend chapter 301, RSMo, by adding thereto one new section relating to a St. Louis College of Pharmacy special license plate.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 301, RSMo, is amended by adding thereto one new section, to be
2 known as section 301.3102, to read as follows:

301.3102. 1. Any vehicle owner who has obtained an annual emblem-use
2 authorization statement from the St. Louis College of Pharmacy may, subject to the
3 registration fees provided in section 301.055, apply for St. Louis College of Pharmacy
4 license plates for any motor vehicle such person owns either solely or jointly, other than
5 an apportioned motor vehicle or a commercial motor vehicle licensed in excess of eighteen
6 thousand pounds gross weight. The St. Louis College of Pharmacy hereby authorizes the
7 use of its official emblem to be affixed on multiyear license plates as provided in this
8 section. Any vehicle owner may annually apply for the use of the emblem. Any
9 contribution to the St. Louis College of Pharmacy derived from this section, except
10 reasonable administrative costs, shall be used solely for the purposes of the St. Louis
11 College of Pharmacy.

12 2. Upon annual application and payment of a twenty-five dollar emblem-use
13 contribution to the St. Louis College of Pharmacy, the St. Louis College of Pharmacy shall
14 issue to the vehicle owner, without further charge, an emblem-use authorization statement,
15 which shall be presented by the vehicle owner to the department of revenue at the time of
16 registration of a motor vehicle. Upon presentation of the annual statement and payment
17 of a fifteen-dollar fee in addition to the regular registration fees and presentation of other
18 documents which may be required by law, the department of revenue shall issue a license

19 plate to the vehicle owner, which shall bear the emblem of the St. Louis College of
20 Pharmacy in a form prescribed by the director, shall bear six letters or numbers and shall
21 bear the words "ST. LOUIS COLLEGE OF PHARMACY" in place of the words
22 "SHOW-ME STATE". Such license plates shall be made with fully reflective material
23 with a common color scheme and design, shall be clearly visible at night, and shall be
24 aesthetically attractive, as prescribed by section 301.130. Notwithstanding the provisions
25 of section 301.144, no additional fee shall be charged for the personalization of license
26 plates pursuant to this section.

27 3. A vehicle owner, who was previously issued a plate with the St. Louis College of
28 Pharmacy emblem authorized by this section but who does not provide an emblem-use
29 authorization statement at a subsequent time of registration, shall be issued a new plate
30 which does not bear the St. Louis College of Pharmacy emblem, as otherwise provided by
31 law. The director of revenue may promulgate rules and regulations for the administration
32 of this section. No rule or portion of a rule promulgated pursuant to the authority of this
33 section shall become effective unless it has been promulgated pursuant to the provisions
34 of chapter 536, RSMo.
