AN ACT

To amend chapter 301, RSMo, by adding thereto one new section relating to special license plates.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 301, RSMo, is amended by adding thereto one new section, to be known as section 301.3096, to read as follows:

- 301.3096. 1. Any member of the Missouri Federation of Square and Round Dance Clubs may receive special license plates as prescribed by this section, for any motor vehicle such person owns, either solely or jointly, other than an apportioned motor vehicle or a commercial motor vehicle licensed in excess of eighteen thousand pounds gross weight, after an annual payment of an emblem-use authorization fee to the Missouri Federation of Square and Round Dance Clubs of which the person is a member. The Missouri Federation of Square and Round Dance Clubs hereby authorizes the use of its official emblem to be affixed on multiyear personalized license plates as provided in this section. Any contribution to the Missouri Federation of Square and Round Dance Clubs derived from this section, except reasonable administrative costs, shall be used solely for the purposes of the Missouri Federation of Square and Round Dance Clubs. Any member of the Missouri Federation of Square and Round Dance Clubs may annually apply for the use of the emblem.**
- 2. Upon annual application and payment of a twenty-five dollar emblem-use**

15 contribution to the Missouri Federation of Square and Round Dance Clubs, the
16 organization shall issue to the vehicle owner, without further charge, an emblem-use
17 authorization statement, which shall be presented by the owner to the department of
18 revenue at the time of registration of a motor vehicle. Upon presentation of the annual
19 statement, payment of a fifteen dollar fee in addition to the registration fee and documents
20 which may be required by law, the department of revenue shall issue to the vehicle owner
21 a personalized license plate which shall bear the emblem of the Missouri Federation of
22 Square and Round Dance Clubs. Such license plates shall be made with fully reflective
23 material with a common color scheme and design, shall be clearly visible at night, and shall
24 be aesthetically attractive, as prescribed by section 301.130.

25 **3. A vehicle owner, who was previously issued a plate with the Missouri Federation**
26 **of Square and Round Dance Clubs emblem authorized by this section but who does not**
27 **provide an emblem-use authorization statement at a subsequent time of registration, shall**
28 **be issued a new plate which does not bear the Missouri Federation of Square and Round**
29 **Dance Clubs emblem, as otherwise provided by law. The director of revenue shall make**
30 **necessary rules and regulations for the administration of this section, and shall design all**
31 **necessary forms required by this section. No rule or portion of a rule promulgated**
32 **pursuant to the authority of this section shall become effective unless it has been**
33 **promulgated pursuant to the provisions of chapter 536, RSMo.**
