### AN ACT

To amend chapter 301, RSMo, by adding thereto two new sections relating to special license plates.

---

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

Section A. Chapter 301, RSMo, is amended by adding thereto two new sections, to be known as sections 301.3098 and 301.3099, to read as follows:

**301.3098. 1. Any member of the Kingdom of Calontir may receive special license plates as prescribed by this section, for any motor vehicle such person owns, either solely or jointly, other than an apportioned motor vehicle or a commercial motor vehicle licensed in excess of eighteen thousand pounds gross weight, after an annual payment of an emblem-use authorization fee to the Kingdom of Calontir, a subdivision of the Society for Creative Anachronism, of which the person is a member. The Kingdom of Calontir hereby authorizes the use of its official emblem to be affixed on multiyear personalized license plates as provided in this section. Any contribution to the Kingdom of Calontir derived from this section, except reasonable administrative costs, shall be used solely for the purposes of the Kingdom of Calontir. Any member of the Kingdom of Calontir may annually apply for the use of the emblem.**

**2. Upon annual application and payment of a twenty-five dollar emblem-use contribution to the Kingdom of Calontir, the organization shall issue to the vehicle owner, without further charge, an emblem-use authorization statement, which shall be presented**

15 by the owner to the department of revenue at the time of registration of a motor vehicle.  
16 Upon presentation of the annual statement, payment of a fifteen dollar fee in addition to  
17 the registration fee and documents which may be required by law, the department of  
18 revenue shall issue to the vehicle owner a personalized license plate which shall bear the  
19 emblem of the Kingdom of Calontir. Such license plates shall be made with fully reflective  
20 material with a common color scheme and design, shall be clearly visible at night, and shall  
21 be aesthetically attractive, as prescribed by section 301.130. Notwithstanding the  
22 provisions of section 301.144, no additional fee shall be charged for the personalization of  
23 license plates pursuant to this section.

24 **3. A vehicle owner, who was previously issued a plate with the Society for Creative**  
25 **Anachronism emblem authorized by this section but who does not provide an emblem-use**  
26 **authorization statement at a subsequent time of registration, shall be issued a new plate**  
27 **which does not bear the Society for Creative Anachronism emblem, as otherwise provided**  
28 **by law. The director of revenue shall make necessary rules and regulations for the**  
29 **administration of this section, and shall design all necessary forms required by this section.**  
30 **No rule or portion of a rule promulgated pursuant to the authority of this section shall**  
31 **become effective unless it has been promulgated pursuant to the provisions of chapter 536,**  
32 **RSMo.**

**301.3099. 1. Any member of the Missouri Civil War Reenactors Association may**  
2 **receive special license plates as prescribed by this section, for any motor vehicle such**  
3 **person owns, either solely or jointly, other than an apportioned motor vehicle or a**  
4 **commercial motor vehicle licensed in excess of eighteen thousand pounds gross weight,**  
5 **after an annual payment of an emblem-use authorization fee to the Missouri Civil War**  
6 **Reenactors Association of which the person is a member. The Missouri Civil War**  
7 **Reenactors Association hereby authorizes the use of its official emblem to be affixed on**  
8 **multiyear personalized license plates as provided in this section. Any contribution to the**  
9 **Missouri Civil War Reenactors Association derived from this section, except reasonable**  
10 **administrative costs, shall be used solely for the purposes of the Missouri Civil War**  
11 **Reenactors Association. Any member of the Missouri Civil War Reenactors Association**  
12 **may annually apply for the use of the emblem.**

13 **2. Upon annual application and payment of a twenty-five dollar emblem-use**  
14 **contribution to the Missouri Civil War Reenactors Association, the organization shall issue**  
15 **to the vehicle owner, without further charge, an emblem-use authorization statement,**  
16 **which shall be presented by the owner to the department of revenue at the time of**  
17 **registration of a motor vehicle. Upon presentation of the annual statement, payment of a**  
18 **fifteen dollar fee in addition to the registration fee and documents which may be required**

19 by law, the department of revenue shall issue to the vehicle owner a personalized license  
20 plate which shall bear the emblem of the Missouri Civil War Reenactors Association. Such  
21 license plates shall be made with fully reflective material with a common color scheme and  
22 design, shall be clearly visible at night, and shall be aesthetically attractive, as prescribed  
23 by section 301.130. Notwithstanding the provisions of section 301.144, no additional fee  
24 shall be charged for the personalization of license plates pursuant to this section.

25         **3.** A vehicle owner, who was previously issued a plate with the Missouri Civil War  
26 Reenactors Association emblem authorized by this section but who does not provide an  
27 emblem-use authorization statement at a subsequent time of registration, shall be issued  
28 a new plate which does not bear the Missouri Civil War Reenactors Association emblem,  
29 as otherwise provided by law. The director of revenue shall make necessary rules and  
30 regulations for the administration of this section, and shall design all necessary forms  
31 required by this section. No rule or portion of a rule promulgated pursuant to the  
32 authority of this section shall become effective unless it has been promulgated pursuant to  
33 the provisions of chapter 536, RSMo.
