### AN ACT

To amend chapter 301, RSMo, by adding thereto one new section relating to special license plates.

---

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

Section A. Chapter 301, RSMo, is amended by adding thereto one new section, to be  
2 known as section 301.3093, to read as follows:

301.3093. 1. Any member of Jefferson National Parks Association may receive  
2 special license plates as prescribed by this section, for any motor vehicle such person owns,  
3 either solely or jointly, other than an apportioned motor vehicle or a commercial motor  
4 vehicle licensed in excess of eighteen thousand pounds gross weight, after an annual  
5 payment of an emblem-use authorization fee to Jefferson National Parks Association of  
6 which the person is a member. Jefferson National Parks Association hereby authorizes the  
7 use of its official emblem to be affixed on multiyear personalized license plates as provided  
8 in this section. Any contribution to Jefferson National Parks Association derived from this  
9 section, except reasonable administrative costs, shall be used solely for the purposes of  
10 Jefferson National Parks Association. Any member of Jefferson National Parks  
11 Association may annually apply for the use of the emblem.

12 2. Upon annual application and payment of a twenty-five dollar emblem-use  
13 contribution to Jefferson National Parks Association, the organization shall issue to the  
14 vehicle owner, without further charge, an emblem-use authorization statement, which shall

15 be presented by the owner to the department of revenue at the time of registration of a  
16 motor vehicle. Upon presentation of the annual statement, payment of a fifteen dollar fee  
17 in addition to the registration fee, and documents which may be required by law, the  
18 department of revenue shall issue to the vehicle owner a personalized license plate which  
19 shall bear the emblem of the Jefferson National Parks Association and shall have the words  
20 "Jefferson National Parks Association" in place of the words "Show-Me State". Such  
21 license plates shall be made with fully reflective material with a common color scheme and  
22 design, shall be clearly visible at night, and shall be aesthetically attractive, as prescribed  
23 by section 301.130. Notwithstanding the provisions of section 301.144, no additional fee  
24 shall be charged for the personalization of license plates pursuant to this section.

25       3. A vehicle owner, who was previously issued a plate with the Jefferson National  
26 Parks Association emblem authorized by this section but who does not provide an emblem-  
27 use authorization statement at a subsequent time of registration, shall be issued a new plate  
28 which does not bear the Jefferson National Parks Association emblem, as otherwise  
29 provided by law. The director of revenue shall make necessary rules and regulations for  
30 the administration of this section, and shall design all necessary forms required by this  
31 section. No rule or portion of a rule promulgated pursuant to the authority of this section  
32 shall become effective unless it has been promulgated pursuant to the provisions of chapter  
33 536, RSMo.
