Whereas, the members of the Missouri House of Representatives hold in high esteem those Show-Me State residents who have developed and maintained exceptional reputations for excellence in their chosen fields of endeavor; and

Whereas, Kevin D. Wallace, D.M.D., of Springfield will be honored at the Salute to Health Care sponsored by the Springfield Area Chamber of Commerce on Tuesday, October 14, 2003; and

Whereas, a practicing Prosthodontist, Dr. Kevin Wallace is a board member of the Springfield Dental Society; trustee of the Missouri Dental Association; chair of Emergency Care for R-12 School Children, and chair of Access to Care, board liaison to the Council of Professional Affairs, and state coordinator for expanded functions for dental assistants, all three with the Missouri Dental Association; and

Whereas, Dr. Kevin Wallace has been married to Rebecca Jo Wallace for many years in a loving relationship which has given him three wonderful children:
