

## House Resolution No. 4654

**Whereas**, it is with special pleasure that the members of the Missouri House of Representatives pause to recognize Staff Sergeant Patrick Reed, who will be honored with an Adopt A Serviceman Award during the Exercise Tiger Association National Commemorative Foundation's 14<sup>th</sup> annual Adopt A Serviceman Program awards dinner to be held November 14, 2003, at the Governor's Mansion in Jefferson City; and

**Whereas**, key speakers for the annual event include United States Congressmen Ike Skelton and Kenny Hulshof, Major General McCarney, TAG Brigadier General Dennis Shull of the National Guard, First Lady Lori Hauser Holden, and several other senior officers from the United States Navy and United States Air Force; and

**Whereas**, the Exercise Tiger Foundation's National Adopt A Serviceman Program began with the awarding of three plaques to veterans of the battle of Tiger in 1989, since which time more than twenty-five separate categories have been established to honor all veterans and to recognize those who have served in the armed forces or who have supported veterans or provided a community service; and

**Whereas**, since 1989, more than seven hundred awards have been given to veterans, elected officials, students, military units, journalists, and other deserving recipients, all of whom have successfully met the criteria for the award for which they have been nominated; and

**Whereas**, established in 1999, the Adopt A Serviceman Program is an annual event for the state of Missouri that recognizes the individual efforts of the enlisted NCO's and personnel of the United States Army, Navy, Marines, Air Force, and Coast Guard; and

**Whereas**, it is entirely fitting and proper that this legislative body should pay tribute to Staff Sergeant Patrick Reed, 1107<sup>th</sup> AVCAD, Missouri Army Reserve National Guard, who was recommended for the Bronze Star for actions in Iraq during Operation Iraqi Freedom:

**Now, therefore, be it resolved** that we, the members of the Missouri House of Representatives, Ninety-second General Assembly, unanimously join in extending our most hearty congratulations to Staff Sergeant Patrick Reed at this proud moment of well-deserved distinction, and in wishing him only the very best of success in all his future endeavors; and
