

## House Resolution No. 2348

**Whereas**, the members of the Missouri House of Representatives hold in high esteem those Show-Me State residents who have proven down through the years to be exemplary citizens in local communities and neighborhoods; and

**Whereas**, F. Russell Shultz of Saint Louis attained considerable distinction as a lead anesthetist and nurse at Saint Johns Hospital who was born in Fort Wayne, Indiana, on January 7, 1918; graduated from Alexian Brothers Hospital School of Nursing as a Registered Nurse in October 1940; and served in the United States Navy as a Pharmacist's Mate First Class and as a Senior First Class Corpsman from 1942 to 1946; and

**Whereas**, Russell Shultz recently enhanced his already impressive record of achievement when he was selected as the Legionnaire of the Year for the 11th/12th District of the Department of Missouri; and

**Whereas**, Russell Shultz joined American Legion Friendship Post #241 shortly after his move to Saint Louis in February 1946 and marriage to his beloved Charlotte; and

**Whereas**, Russell Shultz learned the Legionnaire duties of Adjutant from his father-in-law, after which he served the Post as Commander and Finance Officer; and

**Whereas**, when Friendship Post #241 merged with Quentin Roosevelt Post #1 in 1986, Russell Shultz was elected Adjutant and then Post Commander of the combined organization; and

**Whereas**, Russell Shultz has served on District and Department committees, as a Delegate to District and Department conventions, as a member of the 40&8 Society, and as a committeeman and President of the Saint Louis Past Post Commanders Club; and

**Whereas**, Russell Shultz also has been active as an adult leader with the Boy Scouts of America program and as the treasurer of the Board of the American Railway Caboose Historical and Educational Society; and

**Whereas**, Russell Shultz is justifiably proud to be known as the loving father of three sons, Ford W. Shultz, Alan Shultz, and Robert P. Shultz:

**Now, therefore, be it resolved** that we, the members of the Missouri House of Representatives, Ninety-third General Assembly, join unanimously to applaud the well-deserved selection of Russell Shultz as the Legionnaire of the Year for the 11th/12th District of the Department of Missouri and to convey to him this legislative body's most heartfelt best wishes for continued personal success for many more years to come; and
