Whereas, the members of the Missouri House of Representatives hold in high esteem those Show-Me State residents who have brought glory and honor to themselves and to this great state through the excellence of their achievements in their chosen fields of endeavor; and

Whereas, Karrol Hillebrand of Vandalia has attained considerable distinction as an independent insurance agent at Hillebrand Insurance; and

Whereas, at the 2005 Missouri State Trap Shooting Championships, Karrol Hillebrand recently enhanced his already impressive record of avocational achievement when he won the singles event by hitting 100 of 100 targets and then 75 of 75 targets in a shoot off, class singles by hitting 199 out of 200 targets, singles championship hitting 197 of 200 targets, and doubles championship by hitting 99 of 100 targets, all in the Veteran Class; and

Whereas, Karrol Hillebrand also won the Hall of Fame Handicap event, in which 700 shooters competed, by hitting 98 of 100 targets to be placed in a four-way tie, which he then won by hitting 24 of 25 targets in the shoot off; and

Whereas, Karrol Hillebrand also won the Veteran Class high overall competition, which is based on 1,100 targets during a five-day period, and the High All-around, based on 400 targets; and

Whereas, inducted into the Missouri Trap Shooting Hall of Fame in 1994, Karrol Hillebrand also competed as a member of a five-man squad which shot 1,352 targets before a miss to establish a probable record, shot 500 of 500 targets twice this year, and broke 998 of 1,000 16-yard targets, one short of the world record which the team tied in October 2004; and

Whereas, Karrol Hillebrand is the beloved husband of Grace; loving father of Ivy Mazingo, Vicki Shepherd, Beverly Pfeffer, Myrna Maerz, and Kathy Basinger; devoted grandfather of five wonderful children; and great-grandfather of one:

Now, therefore, be it resolved that we, the members of the Missouri House of Representatives, Ninety-third General Assembly, join unanimously to applaud the accomplishments garnered thus far in the life of Karrol Hillebrand and to convey to him this legislative body's most heartfelt congratulations for his unparalleled success at the 2005 Missouri State Trap Shooting Championships; and
