**Whereas**, NAMI Southwest Missouri provides programs, information, services, support, referrals, education, community outreach, and advocacy to increase the knowledge and understanding of mental illness; improve access to quality care, services, treatment, and opportunities; eradicate stigma and discrimination; and promote equal rights and greater research funding; and

**Whereas**, it is fitting and proper that the Missouri House of Representatives should pause in its diverse daily activities in order to acknowledge milestone events in the lives of such outstanding Missouri citizens as Leigh Rathbun:
