Whereas, the beloved wife of Larry Ellison, Pat Ellison is justifiably proud also to be known as the loving mother of Tammy Redd, Shelly Henry, and Amy Schultz; and

Whereas, it is fitting and proper that the Missouri House of Representatives should pause in its diverse daily activities in order to recognize such outstanding Missouri citizens as Pat Ellison at momentous times in their lives:
