AN ACT

Relating to submission of a proposed federal balanced budget amendment to the United States Constitution.

Be it enacted by the General Assembly of the state of Missouri, as follows:

WHEREAS, under Article V of the Constitution of the United States:

3 "The Congress, whenever two-thirds of both houses shall deem it necessary, shall
4 propose amendments to this constitution, or, on the application of the legislatures of two-thirds
5 of the several states, shall call a convention for proposing amendments, which in either case shall
6 be valid to all intents and purposes as part of this constitution, when ratified by the legislatures
7 of three-fourths of the several states, or by conventions in three-fourths thereof, as the one or the
8 other mode of ratification may be proposed by Congress"; and

10 **WHEREAS**, the following Amendment to the United States Constitution is proposed:

12 "Section 1. The annual expenditures of the Congress shall not exceed the annual revenue
13 for any year, save for the use of monetary reserves, except as provided for in Sections 2 and 3.

15 Section 2. The Congress shall not borrow from any source, including its own funds and
16 trusts, for any expense, except for the extraordinary costs of a declared war or armed conflict,
17 or for a fiscal emergency declared by Congress and signed by the President of the United States.

18
19 Section 3. The Congress may issue special bonds for specific capital projects, which
20 shall, in turn, be extinguished within twenty years of issuance. The cumulative total of all bonds
21 issued in this manner shall never exceed twenty percent of the total private sector earned income.

23 Section 4. This amendment shall take effect beginning the third fiscal year after its
24 ratification.

26 Section 5. This resolution shall not be construed as an application for a constitutional
27 convention to the United States Constitution pursuant to Article V thereof.";

28 **NOW, THEREFORE, BE IT RESOLVED** that the members of the House of
29 Representatives of the Ninety-sixth General Assembly, First Regular Session, the Senate
30 concurring therein, hereby submit this resolution for a federal balanced budget Amendment to
31 the United States Constitution and, pursuant to Article V of the United States Constitution,
32 respectfully urge the United States Congress to submit the proposed Amendment to the United
33 States Constitution to the States for ratification and inclusion in the United States Constitution;

36 **BE IT RESOLVED** that the Chief Clerk of the Missouri House of Representatives be
37 instructed to prepare properly inscribed copies of this resolution for the Majority and Minority
38 Leaders of the United States Senate and House of Representatives, and each member of the
39 Missouri Congressional delegation.
