AN ACT

To amend chapter 37, RSMo, by adding thereto four new sections relating to the Missouri accountability portal.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 37, RSMo, is amended by adding thereto four new sections, to be known as sections 37.855, 37.857, 1 and 2, to read as follows:

37.855. 1. The office of administration shall maintain public school accountability information on the Missouri accountability portal established under section 37.850. The Missouri accountability portal shall provide public access to a complete, transparent, and comprehensive database of school district and charter school financial and policy information as a means of creating better public understanding of public school policies, practices, and operations.

2. The department of elementary and secondary education shall collect and transmit, to the office of administration, the public information applicable to all public schools as provided in this section.

3. School districts and public charter schools shall annually provide the department with detailed compensation information for all school employees including the adopted salary schedules with the number of employees in the various subcategories of the schedules, all extra duty compensation, all employee benefits, the school calendar, the district budget, and local school board or public charter school policies. School districts and charter schools shall provide all information required under this subsection to the department in electronic form in a commonly used electronic format specified by the department.

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

37.857. 1. The office of administration shall maintain county government
2 **accountability information on the Missouri accountability portal established under section**
3 **37.850. The Missouri accountability portal shall provide public access to a complete,**
4 **transparent, and comprehensive database of county government financial and policy**
5 **information as a means of creating better public understanding of county government**
6 **policies, practices, and operations.**

7 **2. Individual county governmental entities shall collect and transmit, to the office**
8 **of administration, the public information applicable to all county governments as provided**
9 **in this section.**

10 **3. Specifically, local governmental entities shall annually provide to the office of**
11 **administration detailed compensation information for all government employees including**
12 **the adopted salary schedules with the number of employees in the various subcategories**
13 **of the schedules, all extra duty compensation, all employee benefits, and the county budget.**
14 **The office of administration shall establish clear standards for budget format and detail,**
15 **to ensure that all county government budgets contain all necessary information and**
16 **present the information according to consistent reporting standards.**

Section 1. The office of administration shall maintain travel accountability
2 **information detailing the Governor’s travel information in the Missouri Accountability**
3 **Portal established under 37.850. The Missouri accountability portal shall provide public**
4 **access to a complete, transparent and comprehensive database of all travel by the**
5 **Governor. The travel information shall include, but is not limited to, the departure date,**
6 **departure time, arrival date, arrival time, accompanying passengers, duration of the trip,**
7 **purpose of the trip, destination, and detailed travel expenses.**

Section 2. 1. The office of administration shall maintain municipal government
2 **accountability information on the Missouri accountability portal established under section**
3 **37.850. The Missouri accountability portal shall provide public access to a complete,**
4 **transparent, and comprehensive database of municipal government financial and policy**
5 **information as a means of creating better public understanding of municipal government**
6 **policies, practices, and operations.**

7 **2. Individual municipal governmental entities shall collect and transmit, to the**
8 **office of administration, the public information applicable to all municipal government as**
9 **provided in this section.**

10 **3. Municipal governmental entities shall annually provide to the office of**
11 **administration a copy of the annual report of the financial transactions of the municipality**
12 **that the municipality is required to provide to the state auditor under section 105.145.**
