1 AMEND House Committee Substitute for Senate Committee Substitute for Senate Bill No. 563,  
2 Page 1, Section A, Line 3, by inserting after all of said section and line the following:

4 “172.030. 1. The board of curators of the University of the state of Missouri shall  
5 hereafter consist of nine members, who shall be appointed by the governor, by and with the advice  
6 and consent of the senate; provided, that [at least one but no more than two shall be appointed  
7 upon said board from each congressional district, and] appointments to the board shall be made so  
8 that at least one person is serving from each congressional district at all times. No person shall be  
9 appointed a curator who shall not be a citizen of the United States, and who shall not have been a  
10 resident of the state of Missouri two years next prior to his appointment. Not more than five  
11 curators shall belong to any one political party. Notwithstanding any provision of law to the  
12 contrary, nothing in this section relating to a change in the composition and configuration of  
13 congressional districts in this state shall prohibit a member who is serving a term on August 28,  
14 2011, from completing his or her term.

15 2. Notwithstanding any other law, the ninth member of the board may be a student curator  
16 who shall have the right to vote on any matter before the board, including the hiring or firing of  
17 the president of the University of Missouri system, the chancellors of each of the university  
18 campuses, the general counsel of the university, the secretary of the board of curators, faculty and  
19 staff, and all other general officers of the university. The first student curator may be appointed in  
20 January 2013 or in January every two years thereafter, and shall serve a two-year term provided  
21 the person maintains the status of a full-time student. If a student curator is appointed under this  
22 subsection, then he or she shall replace the nonvoting student representative appointed under  
23 section 172.035; however, such student curator shall be appointed in the manner prescribed in  
24 section 172.035, and he or she shall meet all other requirements of section 172.035.

25 172.035. 1. The governor shall, by and with the advice and consent of the senate, appoint  
26 a student representative to the board of curators of the University of Missouri, who shall attend all  
27 meetings and participate in all deliberations of the board. Such student representative shall not  
28 have the right to vote on any matter before the board, unless the student representative position on

1 the board is converted to a student curator position, as provided under section 172.030.

2 2. Such student representative shall be a full-time student at the university as defined by  
3 the board, selected from a panel of three names submitted to the governor by the student  
4 government presidents of the campuses of the university, a citizen of the United States, and a  
5 resident of the state of Missouri. No person may be appointed who is not actually enrolled during  
6 the term of such person's appointment as a student at the University of Missouri.

7 3. The term of the student representative shall be two years, except that the person first  
8 appointed shall serve until January 1, 1986.

9 4. If a vacancy occurs for any reason in the position of student representative, the  
10 governor shall appoint a replacement who meets the qualifications set forth in subsection 2 of this  
11 section and who shall serve until the student representative's successor is appointed and qualified.

12 5. If the student representative ceases to be a student at the University of Missouri, or a  
13 resident of the state of Missouri, or fails to follow the board's attendance policy, the student  
14 representative's position shall at once become vacant, unless such absence is caused by sickness or  
15 some accident preventing such representative's arrival at the time and place appointed for the  
16 meeting.

17 6. The student representative shall receive the same reimbursement for expenses as other  
18 members of the board of curators receive pursuant to section 172.040.

19 7. Appointments made under this section shall be made in rotation from each of the four  
20 campuses of the University of Missouri, beginning with a student from the Columbia campus,  
21 next from the Rolla campus, next from the Kansas City campus, and then from the St. Louis  
22 campus. If, after August 28, 2012, the university adds another campus or campuses, then such  
23 campus or campuses shall be inserted into the aforementioned rotation following the St. Louis  
24 campus in the order in which such campus or campuses are admitted into the university.

25 8. Unless alternative arrangements for payment have been made and agreed to by the  
26 student and the university, the student representative shall have paid all student and tuition fees  
27 due prior to such appointment and shall pay all future student and tuition fees during the term of  
28 office when such fees are due.

29 172.040. Except as provided in subsection 2 of section 172.030 for student curators, the  
30 term of service of the curators shall be six years, the terms of three expiring every two years; the  
31 first expiration occurring on the first day of January, 1911, and succeeding expirations of three  
32 members every two years thereafter. Said curators, while attending the meetings of the board,  
33 shall receive their actual expenses, which shall be paid out of the ordinary revenues of the  
34 university.

35 172.060. Except as provided in subsection 2 of section 172.030 for student curators, all  
36 appointments to fill vacancies, except such as may be made to fill out unexpired terms, shall be

1 for the term of six years, and until the successors of such appointees shall be appointed and  
2 qualified.”; and

4 Further amend said bill by amending the title, enacting clause, and intersectional references  
5 accordingly.
