1 AMEND House Committee Substitute for Senate Bill No. 620, Page 1, Section A, Line 3, by
2 inserting immediately after said line the following:

4 "195.060. 1. Except as provided in subsection [3] 4 of this section, a pharmacist, in good
5 faith, may sell and dispense controlled substances to any person only upon a prescription of a
6 practitioner as authorized by statute, provided that the controlled substances listed in Schedule V
7 may be sold without prescription in accordance with regulations of the department of health and
8 senior services. All written prescriptions shall be signed by the person prescribing the same. All
9 prescriptions shall be dated on the day when issued and bearing the full name and address of the
10 patient for whom, or of the owner of the animal for which, the drug is prescribed, and the full
11 name, address, and the registry number under the federal controlled substances laws of the person
12 prescribing, if he is required by those laws to be so registered. If the prescription is for an animal,
13 it shall state the species of the animal for which the drug is prescribed. The person filling the
14 prescription shall either write the date of filling and his own signature on the prescription or retain
15 the date of filling and the identity of the dispenser as electronic prescription information. The
16 prescription or electronic prescription information shall be retained on file by the proprietor of the
17 pharmacy in which it is filled for a period of two years, so as to be readily accessible for
18 inspection by any public officer or employee engaged in the enforcement of this law. No
19 prescription for a drug in Schedule I or II shall be filled more than six months after the date

1 prescribed; no prescription for a drug in schedule I or II shall be refilled; no prescription for a drug
2 in Schedule III or IV shall be filled or refilled more than six months after the date of the original
3 prescription or be refilled more than five times unless renewed by the practitioner.

4 2. A pharmacist, in good faith, may sell and dispense controlled substances to any person
5 upon a prescription of a practitioner located in another state, provided that the prescription was
6 issued according to and in compliance with
7 the applicable laws of that state and the United States, provided that the quantity limitations in
8 subsection 2 of section 195.080 apply to prescriptions dispensed to patients located in this state.

9 _____ 3. The legal owner of any stock of controlled substances in a pharmacy, upon
10 discontinuance of dealing in such drugs, may sell the stock to a manufacturer, wholesaler, or
11 pharmacist, but only on an official written order.

12 [3.] 4. A pharmacist, in good faith, may sell and dispense any Schedule II drug or drugs to
13 any person in emergency situations as defined by rule of the department of health and senior
14 services upon an oral prescription by an authorized practitioner.

15 [4.] 5. Except where a bona fide physician-patient-pharmacist relationship exists,
16 prescriptions for narcotics or hallucinogenic drugs shall not be delivered to or for an ultimate user
17 or agent by mail or other common carrier.

18 195.080. 1. Except as otherwise in sections 195.005 to 195.425 specifically provided,
19 sections 195.005 to 195.425 shall not apply to the following cases: prescribing, administering,
20 dispensing or selling at retail of liniments, ointments, and other preparations that are susceptible
21 of external use only and that contain controlled substances in such combinations of drugs as to
22 prevent the drugs from being readily extracted from such liniments, ointments, or preparations,
23 except that sections 195.005 to 195.425 shall apply to all liniments, ointments, and other
24 preparations that contain coca leaves in any quantity or combination.

25 2. The quantity of Schedule II controlled substances prescribed or dispensed at any one
26 time shall be limited to a thirty-day supply. The quantity of Schedule III, IV or V controlled

1 substances prescribed or dispensed at any one time shall be limited to a ninety-day supply and
2 shall be prescribed and dispensed in compliance with the general provisions of sections 195.005
3 to 195.425. The supply limitations provided in this subsection may be increased up to three
4 months if the physician describes on the prescription form or indicates via telephone, fax, or
5 electronic communication to the pharmacy to be entered on or attached to the prescription form
6 the medical reason for requiring the larger supply. The supply limitations provided in this
7 subsection shall not apply if:

8 (1) The prescription is issued by a practitioner located in another state according to and in
9 compliance with the applicable laws of that state and the United States and dispensed to a patient
10 located in another state; or

11 (2) The prescription is dispensed directly to a member of the United States armed forces
12 serving outside the United States.

13 3. The partial filling of a prescription for a Schedule II substance is permissible as defined
14 by regulation by the department of health and senior services.”; and

16 Further amend said bill by amending the title, enacting clause, and intersectional references
17 accordingly.
