AN ACT

To repeal sections 43.650, 589.400, 589.402, 589.403, 589.405, 589.407, and 589.414, RSMo, and to enact in lieu thereof nine new sections relating to the state sex offender registry, with penalty provisions.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Sections 43.650, 589.400, 589.402, 589.403, 589.405, 589.407, and 589.414, RSMo, are repealed and nine new sections enacted in lieu thereof, to be known as sections 43.650, 589.400, 589.401, 589.402, 589.403, 589.404, 589.405, 589.407, and 589.414, to read as follows:

43.650. 1. The patrol shall, subject to appropriation, maintain a web page on the internet which shall be open to the public and shall include a registered sexual offender search capability.

2. **Except as provided in subsections 5 to 7 of this section**, the registered sexual offender search shall make it possible for any person using the internet to search for and find the information specified in subsection 4 of this section, if known, on offenders registered in this state pursuant to sections 589.400 to 589.425[, except that only persons who have been convicted of, found guilty of or plead guilty to committing, attempting to commit, or conspiring to commit sexual offenses shall be included on this website].

3. The registered sexual offender search shall include the capability to search for sexual offenders by name, zip code, and by typing in an address and specifying a search within a certain number of miles radius from that address.

4. Only the information listed in this subsection shall be provided to the public in the registered sexual offender search:

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

- 14 (1) The name and any known aliases of the offender;
- 15 (2) The date of birth and any known alias dates of birth of the offender;
- 16 (3) A physical description of the offender;
- 17 (4) The residence, temporary, work, and school addresses of the offender, including the
18 street address, city, county, state, and zip code;
- 19 (5) Any photographs of the offender;
- 20 (6) A physical description of the offender's vehicles, including the year, make, model,
21 color, and license plate number;
- 22 (7) The nature and dates of all offenses qualifying the offender to register, **including the**
23 **tier level assigned to the offender under sections 589.400 to 589.425;**
- 24 (8) The date on which the offender was released from the department of mental health,
25 prison, or jail, or placed on parole, supervised release, or probation for the offenses qualifying
26 the offender to register;
- 27 (9) Compliance status of the offender with the provisions of section 589.400 to 589.425;
28 [and]
- 29 (10) Any online identifiers, as defined in section 43.651, used by the person. Such
30 online identifiers shall not be included in the general profile of an offender on the web page and
31 shall only be available to a member of the public by a search using the specific online identifier
32 to determine if a match exists with a registered offender;
- 33 **(11) The original and most recent registration date of the offender;**
- 34 **(12) The status of the offender's term of incarceration, probation, or parole; and**
- 35 **(13) Whether the offender is a repeat offender due to having multiple adjudications**
36 **for separate offenses requiring registration under sections 589.400 to 589.425.**
- 37 **5. Although required to register under sections 589.400 to 589.425, offenders who**
38 **commit felonious restraint under section 565.120 of a nonsexual nature when the victim is**
39 **less than eighteen years of age or kidnapping under section 565.110 of a nonsexual nature**
40 **when the victim is less than eighteen years of age shall be exempt from the public**
41 **notification requirements of this section, if:**
- 42 **(1) There is no other offense for which the offender is required to register;**
- 43 **(2) The offender is not a repeat offender as a result of multiple adjudications for**
44 **the offenses listed in this subsection; and**
- 45 **(3) No sexual conduct, attempted sexual conduct, or conspiracy to commit sexual**
46 **conduct, occurred during the offense.**
- 47 **6. Witnesses afforded federal protection required to register under sections 589.400**
48 **to 589.425 shall be exempt from public notification under 18 U.S.C. Section 3521, et seq.**
49 **while under active federal protection.**

50 **7. Juveniles required to register under subdivision (5) of subsection 1 of section**
51 **589.400 shall be exempt from public notification to include out-of-state, federal, military,**
52 **tribal, territory, District of Columbia, or foreign country.**

589.400. 1. Sections 589.400 to 589.425 shall apply to:

2 (1) Any person who[, since July 1, 1979,] has been or is hereafter [convicted of, been
3 found guilty of, or pled guilty or nolo contendere to committing, attempting to commit, or
4 conspiring to commit a felony offense of chapter 566, including sexual trafficking of a child and
5 sexual trafficking of a child under the age of twelve, or any offense of chapter 566 where the
6 victim is a minor] **adjudicated for an offense listed in section 589.414**, unless such person is
7 [exempted] **exempt** from registering under subsection 7 or 8 of this section **or section 589.401**;
8 or

9 (2) [Any person who, since July 1, 1979, has been or is hereafter convicted of, been
10 found guilty of, or pled guilty or nolo contendere to committing, attempting to commit, or
11 conspiring to commit one or more of the following offenses: kidnapping when the victim was
12 a child and the defendant was not a parent or guardian of the child; abuse of a child under section
13 568.060 when such abuse is sexual in nature; felonious restraint when the victim was a child and
14 the defendant is not a parent or guardian of the child; sexual contact or sexual intercourse with
15 a resident of a nursing home, under section 565.200; endangering the welfare of a child under
16 section 568.045 when the endangerment is sexual in nature; genital mutilation of a female child,
17 under section 568.065; promoting prostitution in the first degree; promoting prostitution in the
18 second degree; promoting prostitution in the third degree; sexual exploitation of a minor;
19 promoting child pornography in the first degree; promoting child pornography in the second
20 degree; possession of child pornography; furnishing pornographic material to minors; public
21 display of explicit sexual material; coercing acceptance of obscene material; promoting obscenity
22 in the first degree; promoting pornography for minors or obscenity in the second degree; incest;
23 use of a child in a sexual performance; or promoting sexual performance by a child; or

24 (3) Any person who[, since July 1, 1979,] has been committed to the department of
25 mental health as a criminal sexual psychopath; or

26 [(4)] **(3)** Any person who[, since July 1, 1979,] has been found not guilty as a result of
27 mental disease or defect of any offense listed in [subdivision (1) or (2) of this subsection] **section**
28 **589.414**; or

29 [(5)] **(4)** Any juvenile certified as an adult and transferred to a court of general
30 jurisdiction who has been [convicted of, found guilty of, or has pleaded guilty or nolo contendere
31 to committing, attempting to commit, or conspiring to commit a felony under chapter 566 which
32 is equal to or more severe than aggravated sexual abuse under 18 U.S.C. Section 2241, which

33 shall include any attempt or conspiracy to commit such offense;] **adjudicated for an offense**
34 **listed in section 589.414; or**

35 [(6)] (5) Any juvenile fourteen years of age or older at the time of the offense who has
36 been adjudicated for an offense which is equal to or more severe than aggravated sexual abuse
37 under 18 U.S.C. Section 2241, which shall include any attempt or conspiracy to commit such
38 offense; **or**

39 [(7)] (6) Any person who is a resident of this state who has[, since July 1, 1979,] **been**
40 or is hereafter [convicted of, been found guilty of, or pled guilty to or nolo contendere]
41 **adjudicated** in any other state, **territory, the District of Columbia,** or foreign country, or under
42 federal, tribal, or military jurisdiction [to committing, attempting to commit, or conspiring to
43 commit] **for** an offense which, if committed in this state, would [be a violation of chapter 566,
44 or a felony violation of any offense listed in subdivision (2) of this subsection] **constitute an**
45 **offense listed in section 589.414,** or has been or is required to register in another state,
46 **territory, the District of Columbia, or foreign country,** or has been or is required to register
47 under tribal, federal, or military law; or

48 [(8)] (7) Any person who has been or is required to register in another state, **territory,**
49 **the District of Columbia, or foreign country,** or has been or is required to register under tribal,
50 federal, or military law and who works or attends an educational institution, whether public or
51 private in nature, including any secondary school, trade school, professional school, or institution
52 of higher education on a full-time or on a part-time basis or has a temporary residence in
53 Missouri. "Part-time" in this subdivision means for more than seven days in any twelve-month
54 period.

55 2. Any person to whom sections 589.400 to 589.425 apply shall, within three **business**
56 days of [conviction] **adjudication,** release from incarceration, or placement upon probation,
57 register with the chief law enforcement official of the county or city not within a county in which
58 such person resides unless such person has already registered in that county for the same offense.
59 **For any juvenile under subdivision (5) of subsection 1 of this section, within three business**
60 **days of adjudication or release from commitment to the division of youth services, the**
61 **department of mental health, or other placement, such juvenile shall register with the chief**
62 **law enforcement official of the county or city not within a county in which he or she resides**
63 **unless he or she has already registered in such county for the same offense.** Any person to
64 whom sections 589.400 to 589.425 apply if not currently registered in [their] **such person's**
65 county of residence shall register with the chief law enforcement official of such county or city
66 not within a county within three **business** days. The chief law enforcement official shall forward
67 a copy of the registration form required by section 589.407 to a city, town, village, or campus
68 law enforcement agency located within the county of the chief law enforcement official[, if so

69 requested. Such request may ask the chief law enforcement official to forward copies of all
70 registration forms filed with such official. The chief law enforcement official may forward a
71 copy of such registration form to any city, town, village, or campus law enforcement agency, if
72 so requested].

73 3. The registration requirements of sections 589.400 through 589.425 are lifetime
74 registration requirements unless:

75 (1) All offenses requiring registration are reversed, vacated or set aside;

76 (2) The registrant is pardoned of the offenses requiring registration **in the state of**
77 **Missouri, or if not in the state of Missouri, pardoned in another state, territory, the District**
78 **of Columbia, or foreign country and the pardon explicitly states that the person is relieved**
79 **of his or her duty to register as a sexual offender;**

80 (3) The registrant is no longer required to register and his or her name shall be removed
81 from the registry under the provisions of [subsection 6 of this] section **589.414**; or

82 (4) The [registrant may petition the court for removal or exemption from the registry
83 under subsection 7 or 8 of this section and the] court orders the removal or exemption of such
84 person from the registry **under section 589.401**.

85 4. For processing an initial sex offender registration the chief law enforcement officer
86 of the county or city not within a county may charge the offender registering a fee of up to ten
87 dollars.

88 5. For processing any change in registration required pursuant to section 589.414 the
89 chief law enforcement official of the county or city not within a county may charge the person
90 changing their registration a fee of five dollars for each change made after the initial registration.

91 6. **The following persons shall be exempt from registering as a sexual offender:**

92 (1) Any person currently on the sexual offender registry [for being convicted of, found
93 guilty of, or pleading guilty or nolo contendere to committing, attempting to commit, or
94 conspiring to commit,] **or who otherwise would be required to register for being adjudicated**
95 **for the offense of felonious restraint of a nonsexual nature** when the victim was a child and
96 he or she was the parent or guardian of the child, nonsexual child abuse that was committed
97 under section 568.060, or kidnapping **of a nonsexual nature** when the victim was a child and
98 he or she was the parent or guardian of the child shall be removed from the registry. However,
99 such person shall remain on the sexual offender registry for any other offense for which he or she
100 is required to register under sections 589.400 to 589.425.

101 7. **The following persons shall be exempt from registering as a sexual offender upon**
102 **petition of the court of jurisdiction under section 589.401; except that, such person shall**
103 **remain on the sexual offender registry for any other offense for which he or she is required**
104 **to register under sections 589.400 to 589.425:**

105 (1) Any person currently on the sexual offender registry [for having been convicted of,
106 found guilty of, or having pleaded guilty or nolo contendere to committing, attempting to
107 commit, or conspiring to commit promoting prostitution in the second degree, promoting
108 prostitution in the third degree, public display of explicit sexual material, statutory rape in the
109 second degree, and no physical force or threat of physical force was used in the commission of
110 the crime may file a petition in the civil division of the circuit court in the county in which the
111 offender was convicted or found guilty of or pled guilty or nolo contendere to committing,
112 attempting to commit, or conspiring to commit the offense or offenses for the removal of his or
113 her name from the sexual offender registry after ten years have passed from the date he or she
114 was required to register] **or who otherwise would be required to register for a sexual offense**
115 **involving:**

116 (a) **Sexual conduct where no force or threat of force was directed toward the victim**
117 **or any other individual involved, if the victim was an adult, unless the adult was under the**
118 **custodial authority of the offender at the time of the offense; or**

119 (b) **Sexual conduct where the victim was at least fourteen years of age and the**
120 **offender was not more than four years older than the victim at the time of the offense; or**

121 (2) **Beginning August 28, 2013, any person currently required to register for the**
122 **following sexual offenses:**

123 (a) **Sexual misconduct second degree under section 566.093;**

124 (b) **Sexual misconduct third degree under section 566.095;**

125 (c) **Promoting obscenity in the first degree under section 573.020;**

126 (d) **Promoting obscenity in the second degree under section 573.030;**

127 (e) **Furnishing pornographic materials to minors under section 573.040;**

128 (f) **Public display of explicit sexual material under section 573.060;**

129 (g) **Coercing acceptance of obscene material under section 573.065; or**

130 (h) **Unlawful sex with an animal under section 566.111.**

131 8. [Effective August 28, 2009,] Any person **currently** on the sexual offender registry for
132 having been [convicted of, found guilty of, or having pled guilty or nolo contendere to an offense
133 included under subsection 1 of this section may file a petition after two years have passed from
134 the date the offender was convicted or found guilty of or pled guilty or nolo contendere to the
135 offense or offenses in the civil division of the circuit court in the county in which the offender
136 was convicted or found guilty of or pled guilty or nolo contendere to the offense or offenses for
137 removal of his or her name from the registry if such person was nineteen years of age or younger
138 and the victim was thirteen years of age or older at the time of the offense and no physical force
139 or threat of physical force was used in the commission of the offense, unless such person meets
140 the qualifications of this subsection, and such person was eighteen years of age or younger at the

141 time of the offense, and is convicted or found guilty of or pleads guilty or nolo contendere to a
142 violation of section 566.068, 566.090, 566.093, or 566.095 when such offense is a misdemeanor,
143 in which case, such person may immediately file a petition to remove or exempt his or her name
144 from the registry upon his or her conviction or finding or pleading of guilty or nolo contendere
145 to such offense] **adjudicated of a tier I, II, or juvenile tier III offense or other comparable**
146 **offense listed in section 589.414 may file a petition under section 589.401.**

147 9. [(1) The court may grant such relief under subsection 7 or 8 of this section if such
148 person demonstrates to the court that he or she has complied with the provisions of this section
149 and is not a current or potential threat to public safety. The prosecuting attorney in the circuit
150 court in which the petition is filed must be given notice, by the person seeking removal or
151 exemption from the registry, of the petition to present evidence in opposition to the requested
152 relief or may otherwise demonstrate the reasons why the petition should be denied. Failure of
153 the person seeking removal or exemption from the registry to notify the prosecuting attorney of
154 the petition shall result in an automatic denial of such person's petition. If the prosecuting
155 attorney is notified of the petition he or she shall make reasonable efforts to notify the victim of
156 the crime for which the person was required to register of the petition and the dates and times
157 of any hearings or other proceedings in connection with that petition.

158 (2) If the petition is denied, such person shall wait at least twelve months before
159 petitioning the court again. If the court finds that the petitioner is entitled to relief, which
160 removes or exempts such person's name from the registry, a certified copy of the written findings
161 or order shall be forwarded by the court to the chief law enforcement official having jurisdiction
162 over the offender and to the Missouri state highway patrol in order to have such person's name
163 removed or exempted from the registry.

164 10.] Any nonresident worker, **including work as a volunteer or intern**, or nonresident
165 student shall register for the duration of such person's employment [and is not entitled to relief
166 under the provisions of subsection 9 of this section] , **including participation as a volunteer**
167 **or intern**, or attendance at any school of higher education **whether public or private, including**
168 **any secondary school, trade school, professional school, or institution of higher education**
169 **on a full-time or part-time basis in this state unless granted relief under section 589.401.**
170 Any registered offender from another state who has a temporary residence in this state and
171 resides more than seven days in a twelve-month period shall register for the duration of such
172 person's temporary residency [and is not entitled to the provisions of subsection 9 of this section]
173 **unless granted relief under section 589.401.**

174 [11. Any person whose name is removed or exempted from the sexual offender registry
175 under subsection 7 or 8 of this section shall no longer be required to fulfill the registration

176 requirements of sections 589.400 to 589.425, unless such person is required to register for
177 committing another offense after being removed from the registry.]

**589.401. 1. A person on the sexual offender registry may file a petition in the
2 division of the circuit court in the county in which the offense requiring registration was
3 adjudicated to have his or her name removed from the sexual offender registry.**

**4 2. A person who is required to register in this state because of an adjudication that
5 was committed in another jurisdiction shall file their petition for removal according to the
6 laws of the state, territory, tribal, or military jurisdiction, the District of Columbia, or
7 foreign country in which their offense was adjudicated. Upon the grant of the petition for
8 removal in the jurisdiction where the offense was adjudicated, such judgment may be
9 registered in this state by sending the information required in subsection 5 of this section
10 as well as one authenticated copy of the order granting removal from the sexual offender
11 registry in the jurisdiction where the offense was adjudicated to the court in the county in
12 which the offender is required to register. On receipt of a request for registration removal,
13 the registering court shall cause the order to be filed as a foreign judgment, together with
14 one copy of the documents and information, regardless of their form. The petitioner shall
15 be responsible for costs associated with filing the petition.**

**16 3. A person required to register as a tier III offender shall not file a petition under
17 this section unless the requirement to register results from a juvenile adjudication.**

**18 4. The petition shall be dismissed without prejudice if the following time periods
19 have not elapsed since the date the person was required to register for his or her most
20 recent offense under sections 589.400 to 589.425:**

21 (1) For a tier I offense, ten years;

22 (2) For a tier II offense, twenty-five years;

23 (3) For a tier III offense adjudicated as a juvenile, twenty-five years.

**24 5. The petition shall be dismissed without prejudice if it fails to include any of the
25 following:**

26 (1) The petitioner's:

27 (a) Full name;

28 (b) Sex;

29 (c) Race;

30 (d) Date of birth;

31 (e) Last four digits of the Social Security number;

32 (f) Address;

33 (g) Place of employment, school, or volunteer status;

34 (2) The offense and tier of the offense that required the petitioner to register;

35 (3) The date the petitioner pled to, was convicted of or was adjudicated for the
36 offense;

37 (4) The date the petitioner was required to register;

38 (5) The case number and court, including county, that entered the original order
39 for the adjudicated sex offense;

40 (6) Petitioner's fingerprints on an applicant fingerprint card;

41 (7) If the petitioner was pardoned or an offense requiring registration was reversed,
42 vacated, or set aside, an authenticated copy of the order;

43 (8) If the petitioner is currently registered under applicable law and has not been
44 adjudicated for failure to register in any jurisdiction and does not have any charges
45 pending for failure to register.

46 6. The petition shall name as respondents the Missouri state highway patrol and
47 the chief law enforcement official in the county or city not within a county in which the
48 petition is filed.

49 7. All proceedings under this section shall be governed under the Missouri supreme
50 court rules of civil procedure.

51 8. The person seeking removal or exemption from the registry shall provide the
52 prosecuting attorney in the circuit court in which the petition is filed with notice of the
53 petition to present evidence in opposition to the requested relief to, or may otherwise
54 demonstrate the reasons why the petition should be denied. Failure of the person seeking
55 removal or exemption from the registry to notify the prosecuting attorney of the petition
56 shall result in an automatic denial of such person's petition.

57 9. The prosecuting attorney in the circuit court in which the petition is filed shall
58 have access to all applicable records concerning the petitioner, including but not limited
59 to criminal history records, mental health records, juvenile records, and records of the
60 department of corrections or probation and parole.

61 10. The prosecuting attorney shall make reasonable efforts to notify the victim of
62 the crime for which the person was required to register of the petition and the dates and
63 times of any hearings or other proceedings in connection with such petition.

64 11. The court shall not enter an order directing the removal of the petitioner's name
65 from the sexual offender registry unless it finds the petitioner:

66 (1) Has not been adjudicated of or have charges pending for any additional
67 nonsexual offense for which imprisonment for more than one year may be imposed since
68 the date that the offender was required to register for their current tier level;

69 (2) Has not been adjudicated of or have charges pending for any additional sex
70 offense that would require registration under sections 589.400 to 589.425 since the date

71 that the offender was required to register for their current tier level, even if the offense was
72 punishable by less than one year imprisonment;

73 (3) Has successfully completed any required periods of supervised release,
74 probation, or parole without revocation since the date that the offender was required to
75 register for their current tier level;

76 (4) Has successfully completed an appropriate sex offender treatment program as
77 approved by a court of jurisdiction or the Missouri department of corrections; and

78 (5) Is not a current or potential threat to public safety.

79 12. In order to meet the criteria required by subdivisions (1) and (2) of subsection
80 11 of this section, the fingerprints filed in the case shall be examined by the Missouri state
81 highway patrol. The petitioner will be responsible for all costs associated with the
82 fingerprint based criminal history check of both state and federal files under section
83 43.530.

84 13. If the petition is denied due to an adjudication in violation of subdivision (1) or
85 (2) of subsection 11 of this section, the petitioner shall not file a new petition under this
86 section until:

87 (1) Ten years have passed from the date of the adjudication resulting in the denial
88 of relief if the petitioner is classified as a tier I offender;

89 (2) Twenty-five years have passed from the date of adjudication resulting in the
90 denial of relief if the petitioner is classified as a tier II offender; or

91 (3) Twenty-five years have passed from the date of the adjudication resulting in the
92 denial of relief if the petitioner is classified as a tier III offender on the basis of a juvenile
93 adjudication.

94 14. If the petition is denied due to the petitioner having charges pending in violation
95 of subdivision (1) or (2) of subsection 11 of this section, the petitioner shall not file a new
96 petition under this section until:

97 (1) The pending charges resulting in the denial of relief have been finally disposed
98 of in a manner other than adjudication as defined under section 589.404; or

99 (2) If the pending charges result in an adjudication, the necessary time period has
100 elapsed under subsection 13 of this section.

101 15. If the petition is denied for reasons other than those outlined in subsection 11
102 of this section, no successive petition requesting such relief shall be filed for at least five
103 years from the date the judgment denying relief is entered.

104 16. If the court finds that the petitioner is entitled to have his or her name removed
105 from the sexual offender registry, the court shall enter judgment directing the removal of

106 **the name. A copy of the judgment shall be provided to the respondents named in the**
107 **petition.**

108 **17. Any person subject to judgment requiring his or her name to be removed from**
109 **the sexual offender registry is not required to register under sections 589.400 to 589.425**
110 **unless such person is required to register for an offense that was different from that listed**
111 **on the judgment of removal.**

112 **18. The court may deny the petition for any legitimate legal justification.**

589.402. 1. The chief law enforcement officer of the county or city not within a county
2 may maintain a web page on the internet, which shall be open to the public and shall include a
3 registered sexual offender search capability.

4 **2. Except as provided in subsections 5 and 6 of this section,** the registered sexual
5 offender search [shall] **may** make it possible for any person using the internet to search for and
6 find the information specified in subsection 3 of this section, if known, on offenders registered
7 in this state pursuant to sections 589.400 to 589.425[, except that only persons who have been
8 convicted of, found guilty of, or plead guilty to committing, attempting to commit, or conspiring
9 to commit sexual offenses shall be included on this website].

10 **3. Only the information listed in this subsection [shall] may be provided to the public**
11 **in the registered sexual offender search:**

12 (1) The name and any known aliases of the offender;

31 **(11) The original registration date and most recent registration date of the**

37 publish in any newspaper distributed in the county or city not within a county the sexual offender
38 information provided under subsection 3 of this section for any offender residing in the county

18 **official in charge of such correctional facility, private jail, or mental health institution of**
19 **the person's possible duty to register under sections 589.400 to 589.425. If such person is**
20 **required to register under sections 589.400 to 589.425, the official in charge of the**
21 **correctional facility, private jailor, the mental health institution shall complete the initial**
22 **registration notification at least seven days prior to release and forward the offender's**
23 **registration within three business days of release to the Missouri state highway patrol and**

25 a standard sex offender registration card upon initial registration in Missouri, as well as
26 all other forms required by the Missouri state highway patrol upon each initial and
27 subsequent registration;

28 (9) "Residence", any place where an offender sleeps for seven or more consecutive
29 or nonconsecutive days/nights within a twelve-month period;

30 (10) "Sexual act", any type or degree of genital, oral, or anal penetration;

32 either directly or through the clothing;

44 or court documentation to determine if a sexual element exists;

170 **Missouri registrants who work, including as a volunteer or unpaid intern, or attend any school**

171 [or training] **whether public or private, including any secondary school, trade school,**
172 **professional school, or institution of higher education** on a full-time or part-time basis [in any
173 other state] **or has a temporary residence in this state** shall be required to report in person to
174 the chief law enforcement officer in the area of the state where they work, **including as a**
175 **volunteer or unpaid intern,** or attend **any** school or training and register in that state.
176 "Part-time" in this subsection means for more than seven days in any twelve-month period.

177 [6.] **9.** If a person, who is required to register as a sexual offender under sections 589.400
178 to 589.425, changes or obtains a new online identifier as defined in section 43.651, the person
179 shall report such information in the same manner as a change of residence before using such
180 online identifier.

181 **10. It is not a defense to a prosecution for a violation of any offense listed in this**
182 **section that the victim was a peace officer masquerading as a minor.**

183 **11. Individuals that are not currently registered due to being adjudicated of a**
184 **sexual offense prior to the initial enactment of state or federal sex offender registry**
185 **legislation shall be required to register for their original offense if:**

186 **(1) The individual is currently incarcerated or under supervision of the Missouri**
187 **department of corrections either for a sexual offense or some other crime; or**

188 **(2) The individual is adjudicated for a felony offense, whether or not a sex offense.**
