**AN ACT**

To repeal section 227.303, RSMo, and to enact in lieu thereof nine new sections relating to highway designations, with a contingent effective date for a certain section.

*Be it enacted by the General Assembly of the State of Missouri, as follows:*

Section A. Section 227.303, RSMo, is repealed and nine new sections  
2 enacted in lieu thereof, to be known as sections 227.303, 227.314, 227.325,  
3 227.404, 227.421, 227.515, 227.517, 227.518, and 227.519, to read as follows:

227.303. 1. The portion of Interstate Highway 70 [within] **from the**  
2 **western city limits of** a city not within a county [to the border with the state  
3 of Illinois] **and proceeding east to mile marker 248** shall be designated the  
4 "Mark Twain Highway".

5 2. **The portion of Interstate Highway 70 contained within a city**  
6 **not within a county, from mile marker 248 to the Illinois border, shall**  
7 **be designated the "Andy Gammon Memorial Highway". The department**  
8 **of transportation shall erect and maintain appropriate signs**  
9 **designating such highway, with the costs for such designation to be**  
10 **paid for by private donations.**

227.314. **The Missouri portion of the bridge on Interstate 55,**  
2 **Interstate 64, Interstate 70, and U.S. Route 40 crossing the Mississippi**  
3 **River between downtown St. Louis and southwestern Illinois, commonly**  
4 **known as the Poplar Street Bridge, shall be designated the**  
5 **"Congressman William L. Clay Bridge". The department of**

6 transportation shall erect and maintain appropriate signs designating  
7 the Missouri portion of such bridge, with the costs for such designation  
8 to be paid for by private donation. The designation under this section  
9 shall supersede any prior name or designation for such bridge.

227.325. The bridge on United States Highway 65 over CST  
2 Overlook Avenue in Greene County shall be designated the "Missouri  
3 Fallen Soldiers Memorial Bridge". The department of transportation  
4 shall erect and maintain appropriate signs designating such bridge,  
5 with the costs for such designation to be paid for by private donations.

227.404. The portion of U.S. Highway 63 in Maries County which  
2 is located within the city limits of Vienna shall be designated the  
3 "Leona Williams Highway". The department of transportation shall  
4 erect and maintain appropriate signs designating such highway, with  
5 the costs to be paid for by private donation.

227.421. The new bridge on Interstate 70 crossing the Mississippi  
2 River between downtown St. Louis and southwestern Illinois shall be  
3 designated the "Stan Musial Memorial Bridge". The department of  
4 transportation shall erect and maintain appropriate signs designating  
5 the Missouri portion of such bridge, with the costs for such designation  
6 to be paid by private donation.

227.515. The portion of Missouri Highway 32 from the city limits  
2 of the City of Farmington northeast to the intersection of Missouri  
3 Highway 144 shall be designated the "Sergeant Jeffery Kowalski  
4 Memorial Highway". The department of transportation shall erect and  
5 maintain appropriate signs designating such highway, with the cost to  
6 be paid for by private donations.

227.517. The portion of Interstate 70 in St. Louis City from Union  
2 Boulevard east to Kingshighway Boulevard shall be designated the  
3 "Police Officer Daryl Hall Memorial Highway". The department of  
4 transportation shall erect and maintain appropriate signs designating  
5 such highway, with the cost to be paid for by private donations.

227.518. The portion of Interstate Highway 70 beginning at  
2 Noland Road and continuing eastward to Lee's Summit Road in Jackson  
3 County within the city limits of Independence shall be designated as  
4 the "Clifton J. Scott Memorial Highway". The department of  
5 transportation shall erect and maintain appropriate signs designating  
6 such highway with the cost for such designation to be paid for by

7 **private donation.**

227.519. The portion of U.S. Highway 69 in Clay County,  
2 beginning from its intersection with Interstate 435, north to its  
3 intersection with Interstate 35, shall be designated the "Irvine O.  
4 Hockaday, Jr. Highway". The department of transportation shall erect  
5 and maintain appropriate signs designating such highway, with the  
6 costs to be paid for by private donations.

Section B. The enactment of section 227.421 of this act shall not become  
2 effective until the state of Illinois designates, through legislative act or otherwise,  
3 the portion of the bridge described in section 227.421 which is owned and  
4 maintained by the state of Illinois as the "Stan Musial Memorial Bridge".
