

HB 397 -- OBSOLETE STATUTORY PROVISIONS

SPONSOR: Peters

This bill repeals specified obsolete statutory provisions regarding:

- (1) The Big Government Get Off My Back Act (Section 1.310, RSMo);
- (2) The mandatory audit by the State Auditor of the Veterans Commission Capital Improvement Trust (Section 42.300);
- (3) The mandatory audit by the State Auditor of the Early Childhood Development, Education and Care Fund (Section 161.215);
- (4) Mandatory monthly payments to the Department of Elementary and Secondary Education to sheltered workshops (Section 178.930);
- (5) The requirement for specified information to be displayed on for-profit receptacles collecting donations of unwanted household items (Section 407.485);

- (7) The Rebuild Damaged Infrastructure Program (Section 33.295);
