FISCAL ANALYSIS

ASSUMPTION

Officials from the **State Tax Commission** and the **Office of the State Auditor** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Officials from the **City of Springfield** and **Newton County Health Department** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

In response to a similar proposal, HB 1243 (2021), officials from the **Lincoln County Assessor's Office, City of Corder, City of Claycomo, City of Kansas City, Kansas City Health Department, Pettis County Ambulance District, Cole Camp Ambulance District, Crawford County 911 Board** and the **Nodaway County Ambulance District** each assumed the proposal would have no fiscal impact on their respective organizations.

In response to a similar proposal, HB 1243 (2021), officials from the **Clinton County Commissioners' Office** indicated there would be a fiscal impact from this proposal, but did not provide any additional information. Conversely, officials from the **Clinton County Clerk's Office** indicated there would not be a fiscal impact from this proposal.

Based on the majority of responses received, **Oversight** does not anticipate a fiscal impact from this proposal. However, Oversight received a limited number of responses from local political subdivisions related to the fiscal impact of this proposal. Oversight has presented this fiscal note on the best information available. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek approval to publish a new fiscal note.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other local political subdivisions were requested to respond to this proposed legislation but did not. A general listing of political subdivisions included in our database is available upon request.

FISCAL DESCRIPTION


The proposed legislation appears to have no direct fiscal impact.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.


