## **FISCAL ANALYSIS**

### **ASSUMPTION**

Officials from the **Office of Administration**, the **Missouri House of Representatives** and the Missouri Senate each assume the proposal will have no fiscal impact on their respective organizations.

**Oversight** notes that the above-mentioned agencies have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

### **FISCAL DESCRIPTION**


The proposed legislation appears to have no direct fiscal impact.
