In my years of using public transit to get work (in New York, Chicago, and Kansas City), I can testify that I have witnessed numerous violent predatory attacks/robbery events, and even a murder during my commutes. Public transit systems are some of the most optimal locations for criminal predators to find people alone and UNARMED. They know that the average law-abiding commuter is DISARMED in compliance with unconstitutional ordinances barring effective tools of self-defense. It is a monstrous construct rigged in favor of the predators. In my experience, attackers tend to come in multiples of 3 or more attackers and there is little defense that the average UNARMED commuter can do against a such overwhelming numbers of attackers. I get very agitated and furious recalling some of these events. Weapons that I have been faced with include box cutting knives, a sharpened screwdriver, but fistblows and kicks were the most common weapons. I used to wait nightly on a train platform to go to my job. Many nights I would be the only person there... until a crew of predators would appear. Occasionally there would be one other rider waiting on the same platform. I mentioned a murder earlier in my comments; well I arrived one night to see that same fellow that would often wait to commute with me some evenings had just been gutted in a robbery attack. He was dead already, and police were surveying the evidence. I was directed to another area of the station, but I will never forget the last view I had of him was a sheet had been draped over him and an enormous lake of blood around his body. I remember that in all such attacks that I experienced, I have felt the same common feeling about all of them: a rage at the elected officials of those jurisdictions that consign those who need to rely on public transit to be disarmed and without a effective fighting chance against those who would rob them, rape them, or murder them. I am blessed to have survived my years of utilizing public transit in urban/high crime areas. Security-wise now, I am much better off; I have a car now and, currently live in a State that largely recognizes my natural human right to self defense and to Keep and BEAR Arms. I am a CCW holder since 2006. So now I usually only need to utilize public transit when my car is in for repairs. But though I personally am now in a more safe conditions, I know that millions more good people remain dependent on public transportation. We must finally end the atrocious transit ordinances restricting carry of lawfully-possessed self defense weapons by citizens. Per Uniform Crime Survey data and the annual Defensive Gun Use survey, Americans using their guns to resist a criminal attack rarely have to fire their weapon. The mere display of a firearm by the defender ends the attack with no shot fired in the overwhelming percentage of attacks. In the past two year period of many politicians downsizing police resources, the average urban resident is now on their own to handle their safety more than ever. Crime rates have skyrocketed in the past two years in most urban areas. I plead with this committee to lead the way in abolishing every one of these evil prohibitions against defensive weapons carry by law-abiding citizens. Whether that prohibition is Federal, State, County, or City level, they must all end. Self Defense and the right to Keep and Bear Arms are fundamental HUMAN RIGHTS! Let the Missouri

Legislature lead the way to this greater good now. Advance and Pass House Bills 1462 and 1660. Thank You, Robert Mills Independence, MO

St Louis Metrolink has already beefed up security by placing onboard guards on requested routes and by working with law enforcement for more presence after a driver was shot and injured in 2019. My name is William Bland and I live in Liberty, MO. I am on the Board of the Western Missouri Shooters Alliance. I am here on behalf of myself and the Alliance. I and the Alliance strongly support this bill and feel it is long overdue to be enacted into law to protect some of our most vulnerable citizens. Current law prevents law abiding citizens from exercising their 2A rights between their homes and a public conveyance, and between the conveyance and their home. This is especially harmful late at night. CCW permit holders are not the problem. They have been photographed, fingerprinted, investigated, and vetted. They have to demonstrate competency with a firearm. Police officers are six times more likely to commit misdemeanors or felonies than CCW permit holders. This is not the first time I have testified in support of this and similar bills.1) I have heard testimony that this would be in violation of some federal law, which has been disproven.2) I have heard testimony that CCW permit holders would unduly alarm many passengers and they would abandon public transportation although it was not explained how passengers would be aware that a CONCEALED weapon was present. It is curious to me that these same passengers are not alarmed to the point of abandonment by criminal elements carrying illegal firearms.3) A representative from the Kansas City Council testified the Council opposes this bill. It is instructive to note this same Council is consistently opposed to any gun rights legislation. They are so opposed that they knowingly passed an ordinance that is in direct violation of Missouri's preemption law.4) A representative from the Kansas City ATA testified that busses were safe because there are security officers on SOME of the busses. This is merely an advertisement as to which busses are most vulnerable.
