On behalf of the tens of thousands of NRA Members in Missouri, I am submitting testimony in strong support of House Bill 1698 which would protect law-abiding citizens right to self-defense while attending church or other place of religious worship.At present, Missouri law prohibits an individual from carrying a concealed firearm into "any church or other place of religious worship without the consent of the minister or person or persons representing the religious organization..." This equates to a blanket ban on the lawful carrying of a firearm for self-defense by a law abiding citizen who has obtained a Missouri CCW Permit. The proposal before you would ensure that law abiding citizens who have a CCW have the right to defend themselves and their families in the event of an attack, while maintaining the private property rights of places of worship. Churches and other places of religious worship will still have the right to prohibit the carrying of firearms if they choose to establish such a policy. There is no evidence that so-called "gun free zones" save lives. Criminals have no regard for the law and studies have shown that these zones are not going to stop them from breaking the law. We do know that right-to-carry in places of worship can save lives. On December 29, 2019, a deranged gunman opened fire at West Freeway Church of Christ near Fort Worth, Texas, killing two members of the congregation. Further bloodshed was prevented that day when concealed carrier Jack Wilson drew his firearm and killed the gunman. Video of the horrifying event revealed that several other members of the congregation were carrying that day and were prepared to defend themselves if Wilson had not been there to halt the attack. For his heroic actions Wilson was presented the Governor's Medal of Courage, Texas's highest civilian honor. Thank you, Chairman Trent and members of the committee for your consideration and support of House Bill 1698.

As a woman who carries concealed for not only my own protection, but also that of my church family as part of our safety team, I am in wholehearted support of HB 1698 & HB 1912 and thank the sponsors for continuing to shepherd this legislative change session after session. Debate on this topic seems to often focus on 'more guns' not being the answer to curbing the violence we see in this world. I do not concur with this assessment, as even the low estimates out there to be found on use of firearms to prevent violence (including just being able to show you have it if needed), far exceed the numbers for firearms used to commit violent acts. Guns save lives. I have no qualms with having my pistol on me along with less lethal means as I keep an eve out each Sunday. We are each precious in His sight and therefore worth defending if endangered. My in-person testimony on this last year included the following: An FBI study shows that between 2000-2017, of the 33 'Active Shooter' incidents where an armed citizen was present; they were able to stop the incident from continuing 75.8%(25) of the time. And additionally successful in reducing the number of lives lost 18.2%(6) of the time. In only 2 incidents (6.1%) was the armed citizen not helpful in any way. And especially to be noted.. There was ZERO times when an armed citizen injured or killed an innocent person. All told, this means the armed citizens were successful 94% of the time. That should dispel the myth that only law enforcement is capable of responding to threats. Many opposed to HB1698 & HB1912 argue that the state should not enact regulations interfering with church control or separation of church and state. But what they are missing (whether intentionally or not) is that the bills indeed do just exactly what they proclaim to wish for.The mention of churches and other places of worship are to be removed from current legislation. Thus, leaving it up to each church to act as any and every other private property has the right to do decide for themselves whether or not to allow concealed firearms in their place of worship. The other argument comes down to the fact that some churches do not like the idea of having to post signage signaling their 'gun-free' policy. Therefore, they prefer the law stay as it is. Could this mean they are in favor of state edicts placed on your houses of worship in some cases then? Would love for someone to ask them that question. A representative on the committee when this bill was heard last year even stated that churches had reached out to her, stating that they didn't want to become like 'sitting ducks' if they were to post the sign. Our Jewish Community firmly defends the Establishment Clause of the Constitution which protects citizens' right to practice their religion as they please, so long as the practice does not run afoul of a "public morals" or a "compelling" governmental interest. This is also commonly referred to as the Separation of Church and State.HB 1698 and 1912 clearly cross the line of this sacred separation. These bills take away the rights of clergy and religious community to determine what is and is not allowed in their private spaces. Missouri law currently automatically bans concealed weapons from houses of worship unless an individual receives "the consent of the minister or person or persons representing the religious organization that exercises control over the place of religious worship." This makes sense. A religious community should be able to define for itself if they desire for individuals to bring guns into their holy place. But these bills would switch the default position so that individuals with a concealed carry endorsement or permit could automatically bring a firearm into a house of worship unless that religious group posted significant signs at every entry. A church, synagogue, mosque, or other house of worship would not be able to determine its own policy regarding concealed guns without either accepting weapons or posting government-mandated signs on their sacred space. Do not take away the power of our community institutions to decide how to create a safe and welcoming environment for our members and quests. Government control has no place in our houses of worship. Please oppose HB 1698 & HB 1912.

The Missouri Catholic Conference (MCC) respectfully opposes HB 1698. Under current Missouri law, gun owners are prohibited from carrying a weapon into a church. Missouri properly recognizes that churches are spaces in which guns have no place as a matter of public policy. They are appropriately considered gun-free zones, because they are spaces in which we meet for worship. HB 1698 changes this paradigm. It makes churches places gun owners can lawfully carry, rather than recognizing them in law as gun-free spaces. Churches wishing to remain gun-free would be required to post signage in a conspicuous place. This signage would likely have to be posted near the sacred space of worship. The MCC views this as an inappropriate and unnecessary intrusion upon religious freedom, which is guaranteed under the First Amendment of the U.S. Constitution.The MCC recognizes that we now live in a society where legally recognized gun-free zones will not always protect innocent people from gun violence. Churches are free under current law, however, to address these situations by establishing security protocols tailored to meet their situation. The MCC believes this is a more appropriate way to address the current proliferation of gun violence than removing churches from the list of places guns are not permitted.
