This discrimation and it breaks the law and policies put in place at St. Louis Public Schools. Because of this, I have been on unpaid administrative leave since October 19, 2021. I have hired a lawyer, along with other employees, but the district keeps pushing back hearings and decisions to end this situation. We want to be back in our classroom with our students!
