The only amount that should be considered in recovery of actual costs are indeed the actual costs that are incurred by the plaintiff - not amounts that were never paid. Although we corrected this in the law a few years ago, clever plaintiffs attorneys have continued to introduce evidence of amounts billed that were never paid in the cost recovery phase. This bill would reinforce the original intent - that costs that were never paid are not considered in the cost recovery phase.
