I'm testifying in opposition to HB 2428 because while there are some really strong parts of this bill. there are parts that I have questions about and, I believe, need to be clarified in the bill.Lines 27-31 are the strongest part of this bill because students need to be able to hear the truth about history, and we can never protect all students from feeling uncomfortable. We can, however, do our best to make students feel comfortable and safe during these discussions. This is a huge improvement on my concerns over previous bills that would construe what these lines protect. Lines 6-7 worry me because often, we do bring current events into our classrooms to make connections between our subjects and what's happening in the world. As written, I feel like it could be construed that a student being in a class where policy issues are being discussed could be seen as a violation of this, even when the goal is only to make connections and not push an agenda. (Obviously, teachers shouldn't push agendas, but I think that's what some prior bills assume many teachers are doing.)Lines 13-14 also worry me because being "advantageously treated" could hurt students. For example, it could hurt students for whom English isn't their first language. Getting into an English Language Learner class could be considered being "advantageously treated." Lines 21-23 worry me because this could ban any mention of white privilege. While the goal of discussing white privilege isn't to guilt white people or make them feel bad, that's what many people assume. The goal is simply to understand how the systems in our country have affected various groups, giving both advantages and disadvantages. I also worry about lines 35-39. What does this look like? Does this bill mean that people can file lawsuits against teachers or districts? IF not, how does this get resolved in a constructive way. I think a lot more clarification needs to be added here to set up a process for how this would happen. As it stands, it opens the door for personal attacks and attacks to destabilize public education though onerous lawsuits that waste time and money better spent on student learning.

I hold a doctorate but found this bill extremely difficult to understand as written. The end of the bill appears to permit litigation against public school teachers. I urge the committee not to go this way. Our teachers are overworked and underpaid as it is, and they should not be put through the stress of litigation. That threat will only drive the best people out of public school education. I also wanted to focus on this passage: "that individuals, by virtue of their race ..., bear collective guilt and are inherently responsible for actions committed in the past . . ." I've seen lawmakers make this sort of charge and wish they would offer examples. Here in Springfield, we had a triple lynching at the beginning of the 20th century. My high school never made me aware of this, and I learned of it only a decade after high school graduation. My point is I have taught at the university level and have taken numerous courses on difficult aspects of history. Yet I have never felt personally responsible for the past. I believe this is inflated political rhetoric that is not of use when designing public school classes. Students are curious and want information about their world. While on the surface, Rep. Dogan's HB 2428 appears to promote "dignity and nondiscrimination" in public schools, the language in the bill is too broad and not clearly defined, and it has the potential to be an "educational gag order" on our teachers. Good morning to the Committee. Chairman Basve, and sponsor Representative DoganMy name is Heather Luby, I currently live in Kirkwood, MO but I was born and raised in the Ozark Mountains where my family has been for 8 generations. I've called St. Louis my home for almost 15 years. My husband Jason and I have two daughters, 7th and 10th grade in Kirkwood, My husband is an Army Veteran and I am an adjunct professor. I am here today as a dedicated voter, a concerned parent, and a member of Missouri Equity Education Partnership and I oppose House Bill 2428 sponsored by Representative Dogan. As someone who has had the privilege of meeting Rep. Dogan in the past, I am certain of his decent character and well meaning intentions and I hope that his previous interactions with me would extend the same feelings. I say this to make clear that my opposition to this legislation today is not based on political party, political agenda, or cultural grievances. I am here to offer logical concerns that I sincerely hope this committee will respectfully consider with an open mind. First and foremost, I oppose this bill because it is written vaquely as to feel more like political appeasement than a legislative document. It's similarity in language and intent to many of the other bills around the country right provides proof that it will be immediately challenged in court and tie up needed taxpayer money and resources. In New Hampshire, where they passed a bill with very similar language, it faced immediate merited legal challenges, from American Federation Teachers, the ACLU, and many others. As of January 12 their Senate Judiciary Committee has had multiple bills introduced that would either repeal or replace it. Hours and hours of time and tax money wasted. The New Hampshire legal challenge and many others with near identical language have faced legal challenges on the basis that it restricts teachers' freedom of speech under the First Amendment of the U.S. Constitution, and also that it violates the Due Process Clause of the Fourteenth Amendment due to its vagueness. It has been pointed out time and time again that the vague and general language of these bills fail to give any "legally precise explanations" of what is and isn't prohibited in the classroom and in this bill in particular, it also fails to precisely define what a private right of action could entail. The vague and at time contradictory language of the bill makes it nearly impossible for teachers to confidently know what they're allowed to teach about historic and societal concepts such as racism, sexism, or discrimination. Moreover, teachers' are threatened with the vaguely ominous "private action" against them, if they are accused of violating the law, it seems that the state's intent in using this language is actually to intimidate teachers to the point of silence. There is no avenue that leads to knowledge, or produces critical thinking, that is constrained by constant threat of legal action or loss of livelihood. This bill sends a message, loud and clear, that you do not believe teachers and/or their local districts are capable of teaching honest and accurate history without government surveillance. Our public school teachers and support staff are dedicated public servants who have stepped up and devoted themselves to teaching our children and they have all spent years in training. Yet, you want to make them targets for undeserved disciplinary proceedings, possible financial ruin should they have to

bear the cost of defending themselves on a teacher's salary against private actions, and all for doing their jobs in accordance with the curriculum that has already been formally adopted by our state. This message of distrust will have consequences. We are currently Rank 45th in the country in teachers pay. How many intelligent, top tier teachers will want to teach in Missouri if we continue to treat them with suspicion? When they are allowed no autonomy and no trust? When saying the wrong thing can get them fired or sued? Teachers spend over 1,000 hours in their classrooms each year, can you imagine having to spend those hours second guessing your every word instead of concentrating on teaching? How many bright young people will want to enter a profession when it is no longer regarded with respect, but with contempt? Missouri isn't exactly nationally renowned for our educational systems as it is - I can't imagine this bill will do anything but harm our chances of improvement, by diminishing our ability to attract and recruit new teachers and distracting our current teachers from doing their jobs. As a voter, I can't see the logic in wasting taxpayer money to draft legislation when it is sure to cost the state a lot of taxpayer money to defend legally, and especially when it is legislation that will understandably drive away any self respected or talented teacher all the while sowing seeds of distrust and anger in our communities. Lastly, I want to make sure I share with you a few examples of what I believe will be the most corrosive consequences of this bill. In NH after this bill became law, the group Moms for Liberty tweeted out they were setting up a "CRT Bounty," and would pay \$500 to whoever was the first to "catch" a teacher in violation. That bill, which I'd like to assume was drafted without malice and with good intentions, unintentionally created a bounty on teachers, and incentivized neighbors and families in communities to go out looking for a perceived violation for their own personal monetary gain. When a petition went around for teachers to show their opposition to the bill, their names were given out by a local conservative talk show, and resulted in death threats to several of the teachers. Remember, it was a bill almost exactly like this one. In Tennessee a bill again very similar to this one was used to challenge of use of the autobiography of Ruby Bridges because when the book explains there was "a large crowd of angry white people who didn't want Black children in a white school" it violated the new law because teachers are not allowed to teach curriculum that can cause "an individual to feel discomfort, guilt, anguish, or another form of psychological distress solely because of the individual's race." Have any of you read this book? A dear friend of mine, Toni Ann Johnson, wrote the screenplay based on this book for Disney. If you have read this book, or seen the movie, you know the absurdity of suing a school over teaching it. But the vague language of their bill allowed it. This kind of legislation invites absurdity. I can't imagine that is what any of you want for Missouri? I grew up being a proud Republican because I was raised to believe we were wise because we understood that it wasn't the government's job to try to solve every problem or attend to every grievance, and that even the most well intended overreach inevitably leads to unintended negative consequences. I'm hoping this committee proceeds wisely. Thank you for your time. Heather Luby

Missouri Lawmakers: This bill is not "non-discriminatory." In fact, it is exclusionary again those who are protected under the Civil Rights Act of 1964. Do the interests of our children STILL not matter after all of these years of racial disparity in legislation, school discipline and achievement?
