Mr. Chairman and members of the committee, my name is Amy Kuo Hammerman, and I am submitting this testimony in opposition of HJR 71 on behalf of the National Council of Jewish Women St. Louis (NCJWSTL). NCJWSTL is a non-profit organization in metropolitan St. Louis, representing over 5,000 members and supporters throughout the state. We focus our work on community service, advocacy, education and philanthropy to improve the quality of life for women, children and families while supporting individual and civil rights, and have been doing so since 1895. HJR 71 would attack our citizen initiative process by making it harder to get a citizen initiative on the ballot and more difficult for measures to pass once on the ballot, making the process difficult if not impossible for many citizens' grass roots efforts. For more than a century, Missouri citizens across the political spectrum have been able to have their voices heard through the initiative petition process. I have a difficult time understanding why legislators wish to fix something that is not broken. HJR 71 increases number of signatures for constitutional amendments from 8% to 10% of registered voters in all eight Missouri Congressional districts, and 5% of voters in all districts for a statutory proposal. This is entirely unnecessary and undercuts democracy. Lawmakers should reject efforts to make direct democracy more difficult. NCJWSTL encourages you to vote no on HJR 71.

The Jewish Community Relations Council (JCRC), guided by Jewish values, advocates, educates, collaborates and mobilizes action on issues important to the Jewish community, 60,000 strong in St. Louis. We are committed to pursuing religious tolerance, civic discourse and social justice in St. Louis and beyond. The Sage Hillel taught "Al tifros min hatzibur," Do not separate yourself from the community (Pirke Avot 2:5). Moreover, it is our responsibility to play an active role in our community and in choosing its leaders. Rabbi Yitzhak taught that "A ruler is not to be appointed unless the community is first consulted" (Babylonian Talmud Berachot 55a). Rabbi Yitzhak further explained that in the Torah, Bezalel could be chosen to build the Tabernacle only with the community's approval. This deeply embedded ethic of political participation has guided Jews to enthusiastically participate in the American electoral process. All of these House Resolutions would make it difficult for our people and all people in our state to participate in the electrical process. Our state constitution gives us the right to initiate legislative action through the petition process. This already onerous and costly process, has helped our community achieve some of its policy objectives, including making health care available to more of our citizens. By making it more difficult to certify a petition, by increasing the number of signatures by nearly 200,000 and increasing the threshold for approval of the initiative from a simple majority to two-thirds of the voters. These changes will make the ballot initiative process too expensive and burdensome for many grassroots efforts - effectively removing power from the people. As people of faith, we oppose any efforts that challenge our ability to participate in the electrocail process and ask you to oppose HJR 102, 70 & 71.

The Missouri Voter Protection Coalition Opposes HJR 71. It undermines Missouri's storied citizen initiative process by making it harder for citizens to place proposed constitutional amendments on the ballot and raising the threshold for passage to near impossible levels, effectively excluding all but the most well-funded efforts from participation, and silencing the voices of Missouri's everyday citizens. HJR 71 proposes making it harder for citizens to place proposed amendments on the ballot by increasing the number of signatures proponents must obtain for proposed constitutional amendments from 8% to 10% of registered voters in all 8 Missouri Congressional districts (rather than 6 of 8). Currently citizens must meet a high threshold of securing signatures of registered voters representing 8% of registered voters in 6 of Missouri's 8 congressional districts for proposed amendments. This would increase the percentage to 10 % and expand the scope to all 8 congressional districts, increasing the number of signatures required. Once on the ballot, HJR 71 also increases the threshold for passage from a simple majority to two-thirds. As a practical matter, this resolution results in the following impacts: * This resolution would significantly increase the number of signatures citizen advocates must obtain potentially by several hundred thousand, making the process more difficult and costly. * By increasing the threshold for passage from a majority to 2/3, the resolution sets a nearly impossible threshold for passage. This means that citizen proposed changes that are supported by a wide majority of Missourians — including measures supported by up to 64 percent of Missouri's voters - would still not pass into law, upending the democratic process that has characterized our electoral process. Measures such as Medicaid Expansion, which was supported by over 60 percent of Missourians, would not pass muster. Lawmakers should applaud Missouri's initiative process and eschew efforts to make direct participation more difficult and elusive for Missouri's citizens.

My name is Elizabeth Franklin, Plattsburg MO and I am submitting the following concerns regarding House Joint Resolution Nos. 70 and 71. I do not support these House Joint Resolutions and am respectively submitting testimony in opposition. Missouri has had a citizen petition initiative process for over 100 years and voter confidence is high for laws passed through the petition process. The ballot initiative process is rigorous. Currently only 40% of the constitutional amendments placed on the ballot via citizen petition initiative have passed, proof that the process is demanding and requires much thought by Missouri voters and exceedingly hard work by interest groups who want an initiative on the ballot. The proposed change to increase the threshold for ballot passage from a majority of votes cast to a majority of registered voters (HJR 70) is not realistic. If I understand correctly, this legislation could result in the following scenario. For example, if 10,000 voters are registered when an initiative is place on the ballot, 5001 must vote to pass this initiative. That means if 4000 total votes are cast, the passage of the initiative is impossible even if 100% of those who choose to vote support the measure. How do these mandatory criteria help the ballot initiative process? It seems this is a disincentive to participation, especially when coupled with the increased signature requirements from 8% to 10% in all eight congressional districts (HJR 71). This requirement is not well thought out and will likely result in passage of few if any ballot initiatives and disenfranchise voters. The measure of success should be from those who choose to vote and cast a ballot on election day. MO has no other standard as restrictive and it's unclear why this constraint is needed. Mr. John Ashcroft has stated it best, "It is through the initiative process that those who have no influence with elective representatives may take their cause directly to the people. The General assembly should be reluctant, therefore, to enact legislation which places any impediments on the initiative power which are inconsistent with the reservation found in the Constitution." Wise words that should be heeded by the current Missouri Assembly. Thank you for the opportunity to provide input on this very important topic.

Thank you for providing me with the opportunity to testify regarding HJR 71. I am a Missouri resident, living in western Kansas City near the state line. I am opposed to HJR 71 as I believe that it would make the ballot initiative process more difficult, more expensive and would decrease citizen (non-politician) participation in government. The existing ballot initiative process has a 110-year history and has advanced citizen initiatives that have been championed by conservatives, liberals and libertarians; it is not just a tool for one party or one type of political thinking. As examples, conservatives advanced term limits and taxing limitations (the Hancock Amendment) through the ballot initiative process.Increasing the required signature threshold from 8% to 10% percentage of voters per district would serve only to make the initiative process more expensive, requiring more money to effect change. I'm concerned that our political processes already require too much money; why make access to money even more important? I also am concerned about the provision that increases the number of districts reaching the 10% threshold from 6 to all 8. In the current structure, even when signatures from 8% of voters in 6 districts have been procured, citizens in all 8 districts still have a chance to vote on that ballot initiative. Here again, the net effect will be to make money more important in how our government works. Most concerning is the requirement of a 2/3s supermajority for passage (vs the current majority). Is any legislator that supports this proposal willing to subject themselves to the same standard? Would they be willing to resign if they only receive 60% of the vote in their own upcoming elections? The supermajority standard would materially weaken the ballot initiative process and reduce the ability of Missouri citizens to participate in government. Recall that the Hancock amendment received 55% approval when it passed; under the proposed standard it would not have been approved. Finally, I believe that legislators should be concerned that the proposal reflects a distrust in the citizens of the state of Missouri. The initiative process has been a functioning part of Missouri's government for more than 110 years because it gives citizens the right to independently propose and advance legislation. It has worked for both conservative and liberal causes, and where it has worked it has been because the citizens of the state of Missouri have willingly used their voices in an informed manner.

This is the kind of thing that makes people dislike and distrust politicians!

Chairman Shaul, Vice-Chairwoman McGaugh, members of the committee; thank you for the opportunity to submit testimony today in opposition to HJR 71 which would prevent the initiative petition process from working for the people of Missouri. Pro-Choice Missouri works to protect and expand every Missourian's right to bodily autonomy, to access essential reproductive healthcare, to access accurate information to make the best decisions for ourselves and our families, and to parent our children in safety and dignity. Moreover, we work to ensure reproductive justice for all Missourians, which involves advocating to reduce disparities based on race, income level, insurance coverage status, and other factors. Over the last 3+ years Pro-Choice Missouri has been heavily invested in several ballot initiatives including Medicaid Expansion, Raise up Missouri, and Clean Missouri. We had a team of 7 people who collected more than 5.500 signatures to help get Medicaid Expansion on the ballot. This number is only a fraction of the total 120,000 signatures that were collected by the larger campaign. Everyday our employees got up in the sun, the wind, the snow, and the rain, to speak to strangers on street corners all across the First and Second Congressional Districts. They waited on metro platforms for hours on freezing days being rejected by strangers, hoping for a few good conversations. The most densely populated neighborhoods in St Louis to the most lonely country roads. Under current law, initiative petitions proposing constitutional amendments must be signed by 8% of the legal voters who voted in the last gubernatorial election in each of two-thirds of the congressional districts. The proposed constitutional amendments in HJR 71, if approved by the voters, require such petitions to be signed by 10% of the legal voters in each of the congressional districts. The proposed increase in the threshold for constitutional reform would make Missouri the most difficult state in the country for constituents to participate in the democratic process. Our small nonprofit organization puts considerable effort into supporting these ballot initiatives, and makes up only a small fraction of the signatures already required. This amendment would require over 100,000 more signatures and would make it so only well financed groups could access the ballot. This change denies the people their voice in the process and preferences large monied organizations. HJR 71 would make the ballot initiative process prohibitively difficult, because the task is already a monumental one. The measure is retaliatory to the millions of voters who voted in favor of medical marijuana, ethics reform, medicaid expansion, and so much more. Family well-being is directly tied to the ability to effectively participate in our legislative process and affect meaningful change. Missourians have spoken. They may be at ideological odds with some of you on this committee but that does not warrant you taking away their right to have a direct voice in government through this process. A NO vote is a vote to listen to Missourians. These resolutions will have lasting negative impacts in Missouri. Pro-Choice Missouri, representing more than 70,000 members across the state, opposes the advancement of these resolutions, and urges you to vote NO today. Thank you.

I can tell you from personal experience the petition process as it exists now is not easy. I am proud that Missouri allows citizens to participate in democracy by electing representatives but also directly having our voices heard through the petition initiative process. As a teacher, a former social worker. and community member, I witnessed the devastating effects of predatory lending on our most vulnerable. Missouri is one of least regulated states in the country and it is legal for predatory lenders, through a loophole created by other changes in banking and lending laws, to charge over 1900% interest on loans. And there are other ways people are tricked into the debt trap, which is the actual business model of some of these businesses. A broad group of faith leaders and other concerned people decided to try to get reform through the initiative process. I worked six hours a day, six and seven days a week collecting signatures. In my town, Springfield, we are limited to only a few locations where we are publicly allowed to collect. The process has deadlines and while door to door is another way, it is much slower. We had hundreds of volunteers and limited money for paid collectors. Many of us were harassed, followed by well-paid blockers, even threatened. It was not easy. The billion dollar a year industry prevailed, challenging signatures, even those of well-known clergy who participated in our efforts. (They didn't sign their own petition.) Although we raised money for lawyer's fees, we could not afford to defend all the frivolous claims on signatures. Petitions initiatives shouldn't be held to a higher standard than our legislature. Raising the bar is a cynical attempt to silence our voices on matters that mean so much to us. Do I agree with all petitions? No, I do not. However, I believe we should have the freedom to petition our government, have access to direct democracy via petition. I want Missouri to be a place where we know we have ways to have our voices heard!

House Joint Resolution No. 71 seeks to weaken Missourians' power by making it harder to propose and approve constitutional amendments that are initiated by Missouri citizens who wish to improve their health and living conditions. For this reason, we respectfully ask that you oppose HJR 71. The constitutional amendment outlined in HJR 71 specifically requires initiative petitions to be signed by 10% of legal voters in each congressional district in Missouri if the petition is proposing a constitutional amendment and 5% of such voters if the petition is proposing a law. This modifies the current requirement that petitions be signed by 8% of voters in two-thirds of the congressional districts if the petition is proposing a constitutional amendment and 5% of such voters if the petition is proposing a law. The official fiscal analysis of HJR 71 projects that this will increase the number of required signatures by 75% for constitutional measures and 40% for statutory petitions, which would make it significantly more difficult for Missourians to make their voices heard.HJR 71 also seeks to modify Article XII Section 2(b) of the Missouri Constitution to require a two-thirds supermajority vote to approve constitutional amendments that arise from initiative petitions, which differs from the current requirement of a simple majority vote. This would make it significantly more difficult for Missourians to pass amendments that could meaningfully improve their lives. Of all the petition-initiated constitutional amendments that were on the ballot from 2000-2020, 60% passed with a simple majority but only 20% would have passed if they required a two-thirds supermajority.(1, 2)HJR 71 continues to try and silence the people's voice by requiring measures proposed by initiative to achieve a two-thirds majority vote to pass, while only requiring measures proposed by the general assembly to pass by simple majority.In addition, it is clear that HJR 71 is an attempt to slow the recent wave of amendments that Missouri's citizens have directly proposed. From 2000-2015, only 23% of proposed constitutional amendments on the ballot were initiated through the petition process.(1, 2) However, from 2016-2022, 50% of such amendments have been initiated by a petition.(2) It is apparent that Missourians have chosen to engage more directly in the legislative process in recent years due to frustration with the bureaucracy in Jefferson City, but HJR 71 seeks to punish them for it. We urge you to take a long-term view and think about what is best for Missouri's citizens, as well as the state's democratic processes. Once again, the Missouri Coalition for the Environment asks you to vote "no" on HJR 71 in order to preserve the right of Missourians to propose and pass life-improving amendments. The Association appreciates the opportunity to present written testimony regarding HJR 71. The Association opposes the joint resolution.HJR 71 increases the initiative petition signature percentage for constitutional amendments from 8% to 10% of the legal voters in each Congressional district, requires collection of the required percentage of signatures in all eight Congressional districts, rather than the current requirement of six districts, and requires a two-thirds majority for the approval of any future constitutional amendment, regardless of whether submitted by the legislature or the initiative petition. The Association supports removing barriers for eligible citizens to vote and participate politically. The initiative petition process is already a significant and challenging effort. The Association is concerned that these changes would make the process so difficult that, as a practical matter, the initiative petition process would no longer be a realistic option for Missouri citizens to bring issues of concern forward for public consideration. On behalf of the Association, I thank you for the opportunity to offer our testimony on this issue.

I strongly oppose HJRs 102, 70, and 71, efforts to amend our Missouri Constitution regarding citizens' rights to petition for new amendments and laws or the right to referendum on laws passed by our legislature. If making direct democracy via petitioning or referendum is the goal of the current legislature, perhaps that is the amendment to put on the ballot. Knowing, however, that a significant majority of Missourians survey in favor of these rights, the strategies proposed in HJRs 102, 70, and 71 appear to be ones of making the petition process untenable without stating so transparently. These proposals have the obvious aim of destroying citizens' direct participation in our democracy but are being couched in deceptive language and falsely promoted as ways to "strengthen" the process.An example of possible deception is the official ballot language included in HJR 71: "Allow only citizens of the United States to qualify as legal voters" as the first point in the ballot language. In order to be a registered voter in Missouri one must be a U.S. citizen, so this language serves no purpose aside from pandering to those who believe that non-citizens are allowed to vote. Missouri's century-old petition process is already sufficiently stringent. Though hundreds of petitions have been filed during this period, only a fraction have made it to ballots. And less than half of proposed issues that made it to the ballot have actually passed with a 50% or greater majority. Increasing the number of signatures required would make costs and efforts prohibitive for almost all constituent factions, liberal or conservative. In addition, increasing the required vote tally to two-thirds would prevent passage of almost all proposals. Examples that show the obstructionism of a two-thirds requirement: Medical marijuana passed with 65.5%; Medicaid Expansion passed with 53.25%; the Hancock Amendment passed with 55.41%; and the citizen-initiated 2018 Amendment 1 regarding lobbying, campaign finance, and redistricting passed by 62% but was overturned by the legislature-initiated Amendment 3 in 2020 with only a 51% majority. One might argue that Missouri would be better off without some of these and several other amendments, but the point relevant to HJRs 102, 70, and 71 is that none of them would have passed at a two-thirds level, so it is obvious that the legislature's goal is to, in truth, eliminate the process. BEFORE THE HOUSE STANDING COMMITTEE ON ELECTIONS AND ELECTED OFFICIALS Testimony Opposing House Joint Resolutions 102, 70, and 71

Hearing: Noon January 26, 2022 Jefferson CityGood Afternoon Chairman Shaul, Vice Chairman McGaugh, Ranking Member Windham, and Honorable Representatives. Thank you for the opportunity testify in writing before you today. I previously submitted testimony to this Committee opposing HJR 91 on January 11, 2022 and opposing HJRs 71, 91, and 102 on January 18. My name is Stephen Skrainka, I live in University City. For identification only I am a member of the Voting Rights Chavurah of the Central Reform Congregation in St. Louis, a member of the League of Women Voters of Metro St. Louis Education Committee, a member of the Jewish Community Relations Council's Policy Advisory Committee, a member of the Council on Racial Equality, and a member of the Missouri Voter Protection Coalition. I am also an attorney and a founder and Past President of Central Reform Congregation. I am testifying as an individual, not as a representative of any of these organizations.

My reasons for opposing these bills are as stated in my prior January 11 and January 18 testimony. This combination of bills only compete in the how much more impossible they make the people's use of this most democratic right to petition to solve people's grievances than the previous resolutions. You have in some ways saved the worst for last: As you know these resolution or some of them increase the number of signers required, require signed petitions from every congressional district, require 2/3 majorities of registered voters to approve (in some Resolutions only for the people's initiatives, not yours), repeatedly show your distrust of all Missourians who live in urban areas by such requirements and in HJR 88 by even requiring a 2/3 majority from every county in the state for a proposition to pass! These proposals throw out the baby with the bath water. Many of you are deeply offended that the public grew tired of the our legislature's near 10-year stall of Medicaid expansion and passed it to cover 275,000 needy Missourians by initiative. Some also resent that when we grew tired of badly gerrymandered representation, more beholden to lobbyists than voters, we tried to do away with it by passing Clean Missouri. Or was it passing medical marijuana that upset you? If that's the problem why not just pass a resolution repealing Missouri's entire 115 year old initiative petition process? It would be more forthright. All of these present resolutions are outrageously antidemocratic and should be killed in this committee. I urge you to look at all the many initiative proposals you would have favored that failed to get enough signatures or votes under the current law and pause before you chop the whole thing down. Many conservative measures have been adopted over the years through this process including limitations on Missouri's budget and spending. The present process is truly non-partisan, quite difficult and expensive, and rarely succeeds as Ben Senturia's January 11 testimony shows. Don't destroy the process merely because you don't agree with the last few measures the people have adopted. Deal with the merits of these proposals instead.
