2.	For the purposes of sections 67.1401 to 67.1571, the following words and terms mean
(1)	"Approval" or "approve", for purposes of elections pursuant to sections 67.1401 to
67.1571, a	simple majority of those qualified voters voting in the election;
(2)	"Assessed value", the assessed value of real property as reflected on the tax records of
the county	clerk of the county in which the property is located, or the collector of revenue if the
property is	s located in a city not within a county, as of the last completed assessment;
(3)	"Blighted area", an area which:
(a)	By reason of the predominance of defective or inadequate street layout, insanitary or
unsafe con	aditions, deterioration of site improvements, improper subdivision or obsolete platting
or the exis	tence of conditions which endanger life or property by fire and other causes, or any
combination	on of such factors, retards the provision of housing accommodations or constitutes an
economic	or social liability or a menace to the public health, safety, morals or welfare in its
present co	ndition and use; or
(b)	Has been declared blighted or found to be a blighted area pursuant to Missouri law
including,	but not limited to, chapter 353, sections 99.800 to 99.865, or sections 99.300 to 99.71
(4)	"Board", if the district is a political subdivision, the board of directors of the district,

1	or if the district is a not-for-profit corporation, the board of directors of such corporation;
2	(5) "Director of revenue", the director of the department of revenue of the state of
3	Missouri;
4	(6) "District", a community improvement district, established pursuant to sections
5	67.1401 to 67.1571;
6	(7) "Election authority", the election authority having jurisdiction over the area in which
7	the boundaries of the district are located pursuant to chapter 115;
8	(8) "Municipal clerk", the clerk of the municipality;
9	(9) "Municipality", any city, village, incorporated town, or county of this state, or in any
10	unincorporated area that is located in any county with a charter form of government and with
11	more than one million inhabitants;
12	(10) "Obligations", bonds, loans, debentures, notes, special certificates, or other evidences
13	of indebtedness issued by a district to carry out any of its powers, duties or purposes or to refund
14	outstanding obligations;
15	(11) "Owner", for real property, the individual or individuals or entity or entities who own
16	a fee interest in real property that is located within the district or their legally authorized
17	representative; for business organizations and other entities, the owner shall be deemed to be the
18	individual [which] who is legally authorized to represent the entity in regard to the district.
19	Notwithstanding subsection 2 of section 115.137 to the contrary, the legally authorized
20	representative of an entity owning real property in a district may vote in any district election if
21	otherwise authorized to vote under sections 67.1401 to 67.1571;
22	(12) "Per capita", one head count applied to each individual, entity or group of individuals
23	or entities having fee ownership of real property within the district whether such individual, entity
24	or group owns one or more parcels of real property in the district as joint tenants, tenants in

26	condominium created under sections 448.1-101 to 448.4-120, "per capita" means one head count

10	in a city not within a county, as of the thirtieth day prior to the date of the applicable election;
11	(b) For purposes of elections for approval of business license taxes or sales taxes:
12	a. Registered voters; or
