**FISCAL ANALYSIS**

**ASSUMPTION**

Officials at the **Platte County Board of Election Commission** assume a savings of \$1,000 to \$5,000 for any district requiring a recount of the vote.

Officials at the **Kansas City Board of Election Commission** assume a savings of roughly \$10,000 per election.

Officials at the **St. Louis County Board of Election Commission** assume they had 10 recounts from 2006 to 2010 some of which required substantial manpower costs. Recounts can take 15 to 300 man days to complete. Reducing the number of recounts could result in cost savings.

Officials at the **Lawrence County** and the **Office of the Secretary of State** assume that there is no fiscal impact from this proposal.

Officials at the following board of election commissions: St. Louis City Board of Election Commission, Clay County Board of Election Commission, Jackson County Board of Election Commission and St. Louis County Board of Election Commission did not respond to **Oversight's** request for fiscal impact.

Officials at the following counties: Andrew, Barry, Bates, Boone, Buchanan, Butler, Callaway, Camden, Cape Girardeau, Carroll, Cass, Clay, Cole, Cooper, DeKalb, Franklin, Greene, Hickory, Holt, Jackson, Jasper, Jefferson, Johnson, Knox, Laclede, Lafayette, Lincoln, Marion, Miller, Moniteau, Monroe, Montgomery, New Madrid, Nodaway, Ozark, Pemiscot, Perry, Phelps, Platte, Pulaski, Scott, St. Charles, St. Louis, St. Francois, Taney, Texas, Warren, and Webster did not respond to **Oversight's** request for fiscal impact.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
