FISCAL ANALYSIS

ASSUMPTION

Officials at the **Buchanan County, Kansas City Board of Election Commission, Johnson County, Lawrence County, Office of the Secretary of State, Platte County Board of Election Commission** and the **St. Louis County Board of Election Commission** assume there is no fiscal impact from this proposal.

Oversight assumes this proposal outlines qualifications to be a candidate and therefore would have no fiscal impact on state or local election authority funds.

Officials at the following board of election commissions: St. Louis City Board of Election Commission, Clay County Board of Election Commission and the Jackson County Board of Election Commission did not respond to **Oversight's** request for fiscal impact.

Officials at the following counties: Andrew, Barry, Bates, Boone, Butler, Callaway, Camden, Cape Girardeau, Carroll, Cass, Clay, Cole, Cooper, DeKalb, Franklin, Greene, Hickory, Holt, Jackson, Jasper, Jefferson, Knox, Laclede, Lafayette, Lincoln, Marion, Miller, Moniteau, Monroe, Montgomery, New Madrid, Nodaway, Ozark, Pemiscot, Perry, Phelps, Platte, Pulaski, Scott, St. Charles, St. Louis, St. Francois, Taney, Texas, Warren, and Webster did not respond to **Oversight's** request for fiscal impact.

Senate Amendment 1

In response to similar legislation filed this year, SB 815 the following responded:

Officials from the **City of Hillsboro** stated that they already contract with Jefferson County for animal pound services and real estate and personal property tax collection. Therefore, there is no obvious fiscal impact to the City.

Officials from the **County of Jefferson, City of Arnold** and **City of De Soto** did not respond to Oversight's request for fiscal impact.

Oversight assumes this proposal is discretionary and would have no local fiscal impact without action by the governing body.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
