Bill Summary: This proposal establishes a procedure by which insurers who purchase vehicles through the claims adjustment process can obtain a salvage title or junking certificate when the insurer is unable to obtain a negotiable title.

FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Public Safety - Missouri Highway Patrol, Department of Insurance, Financial Institutions and Professional Registration** each assume the proposal will have no fiscal impact on their respective organizations.

Officials from the **St. Joseph Police Department** and **Department of Transportation** did not respond to our request for fiscal impact.

Officials from the **Department of Revenue (DOR) - Motor Vehicle Bureau (MVB)** state procedures will need to be revised by a Management Analyst Specialist I requiring 40 hours of overtime at a cost of \$1,182. The Department's web site will need to be updated. This will require 10 hours of overtime for an Administrative Analyst III, at a cost of \$319.

To process these additional record lookups the department will require staff to research the record presented in the correspondence and prepare a response. Based on current Department expectations, 1 FTE (Revenue Processing Tech II) will be required to process these record lookups and responses year with equipment, floor space, and expenses associated with this FTE requirement at a cost of \$42,091 in FY 13, \$45,162 in FY 14, and \$45,630 in FY 15

Oversight assumes DOR is provided with core funding to handle a certain amount of activity each year. Oversight assumes DOR could absorb the costs related to this proposal. If multiple bills pass which require additional staffing and duties at substantial costs, DOR could request funding through the appropriation process.

The proposed legislation appears to have no fiscal impact.

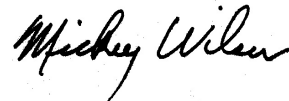
This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
