1 AMEND House Committee Substitute for Senate Committee Substitute for Senate Bill No. 117,
2 Page 2, Section 253.048, Line 6, by inserting after all of said line the following:

4 "447.559. All abandoned tangible personal property delivered to the treasurer pursuant to
5 subdivision (4) of section 447.505 that has possible historical significance shall be reviewed as
6 follows:

7 (1) The treasurer at the treasurer's discretion shall screen such property to determine if the
8 property indicates a need for further review;

9 (2) In the event it is determined that such property needs further review, the treasurer shall
10 make available such property to the state historical society of Missouri for historical review. The
11 state historical society shall issue to the treasurer its report and recommend to the treasurer the
12 appropriate state department or agency to act as custodian of any property deemed to be of such
13 historical significance as to be retained;

14 (3) The state historical society shall receive a reasonable fee for its services. If the treasurer
15 and the state historical society cannot agree on the amount of the fee, the commissioner of
16 administration shall determine the fee. The fee shall be paid out of appropriations made from the
17 abandoned fund account;

18 (4) The [state treasurer's office] treasurer upon receiving military medals shall hold and
19 maintain such military medals until the original owner or [their] such owner's respective heirs or
20 beneficiaries can be identified and the military medal returned. The treasurer is authorized to make
21 the information described in subsection 4 of section 447.560 available to the public in order to
22 facilitate the identification of the original owner or such owner's respective heirs or beneficiaries.
23 The [state] treasurer may designate a [veteran's] veterans' organization or other appropriate
24 organization as custodian of military medals until the original owner or their respective heirs or
25 beneficiaries are located and to assist the treasurer in identifying the original owner or such owner's
26 respective heirs or beneficiaries; except that, no person or entity entering into an agreement under
27 section 447.581 shall be designated by the treasurer as custodian or military medals, and any
28 agreement to pay compensation to recover or assist in the recovery of military medals delivered to
29 the treasurer is unenforceable.

30 447.560. 1. The treasurer shall retain a record of the name and last known address of each
31 person appearing from the holders' reports to be entitled to the abandoned moneys and property and
32 of the name and last known address of each insured person or annuitant, and with respect to each

1 policy or contract listed in the report of a life insurance corporation, its number, the name of the
2 corporation, and the amount due. The record shall be available for public inspection at all reasonable
3 business hours.

4 2. Except as specifically provided by this section, no information furnished to the treasurer
5 in the holder reports, including Social Security numbers or other identifying information, shall be
6 open to public inspection or made public. Any officer, employee or agent of the treasurer who, in
7 violation of the provisions of this section, divulges, discloses or permits the inspection of such
8 information shall be guilty of a misdemeanor.

9 3. If an amount is turned over to the state that is less than fifty dollars, the amount reported
10 may be made available as public information, along with the name and last known address of the
11 person appearing from the holder report to be entitled to the abandoned moneys; except that, no
12 additional information other than provided for in this section may be released, and any individual
13 other than the person appearing from the holder report to be entitled to the abandoned moneys shall
14 be governed by sections 447.500 to 447.595 and other applicable Missouri law in his or her use or
15 dissemination of such information.

16 4. If the abandoned property is a military medal, the treasurer is authorized to make any
17 information, other than Social Security numbers, contained in the holder report and record under
18 subsection 1 of this section, and any photograph or other visual depiction of the military medal
19 available to the public in order to facilitate the identification of the original owner or such owner's
20 respective heirs or beneficiaries as described under subdivision (4) of section 447.559."; and
