ASSUMPTION

§ 262.005 - Right to Raise Livestock:

Officials from the **Department of Agriculture** assume the proposal would not fiscally impact their agency.

Officials at the **Office of Attorney General (AGO)** assumes that any potential costs arising from this proposal can be absorbed with existing resources. Since the proposal could be the subject of litigation, the AGO assumes that costs are unknown. If significant cases result over time, the AGO would seek additional appropriation.
