1 AMEND House Committee Substitute for Senate Committee Substitute for Senate Bill No. 380,
2 Page 9, Section 192.926, Line 47, by inserting immediately after said line the following:

4 "208.205. 1. The task force directed to develop a strategy for implementation of a statewide
5 care delivery model for MO HealthNet managed care shall incorporate the following standards in its
6 strategy to guide the implementation of an expanded role for prepaid capitated health plans in
7 covering MO HealthNet enrollees. Completion of the task force's work to develop such strategy
8 shall be a prerequisite to the department of social services' and the office of administration's
9 development of standards for contracts to implement a broader role for prepaid capitated health plans
10 in the MO HealthNet program.

11 2. The MO HealthNet division shall develop and implement standardized utilization review
12 protocols to be used by all prepaid capitated health plans for determining medical necessity for MO
13 HealthNet services and for authorizing payment for such services. The development of such
14 protocols shall involve the consultation and active engagement of health care providers, as such term
15 is defined in section 376.1350, who are network providers of a prepaid capitated health plan
16 providing services to MO HealthNet enrollees and are not employed by such a plan or plans.

17 3. The MO HealthNet division shall develop recommendations to the general assembly
18 regarding federal, regional, or statewide waivers or state plan amendments, or both, to expand MO
19 HealthNet's flexibility and capacity to reimburse providers through prepaid capitated health plans.
20 Such waivers or demonstration projects shall include, but not be limited to, the federal Delivery
21 System Reform Incentive Payment Program.

22 4. The MO HealthNet division, in collaboration with the department of insurance, financial
23 institutions and professional registration, shall establish network adequacy standards for prepaid
24 capitated health plans that provide for comparable access to adult and pediatric primary care and
25 specialty medical care and behavioral health services as is provided to enrollees of the three largest
26 private insurers regulated by the department under chapter 376.

27 5. Prepaid capitated health plans shall be subject to the payment standards of subsection 1 of
28 section 208.950 regarding their effectiveness in curtailing nonemergency use of hospital emergency
29 department services and in meeting performance metrics regarding quality of care and enrollee and
30 provider satisfaction.

31 6. The MO HealthNet division shall follow the standards of sections 208.950 to 208.951 in
32 providing for multiple models for delivering care management services to MO HealthNet enrollees.
33 Such models shall include risk-bearing coordinated care plans or prepaid capitated health plans,
34 administrative services organizations, and coordinated fee-for-service plans, as well as
35 provider-sponsored care management programs such as accountable care organizations."; and
