SPONSOR: Burlison

COMMITTEE ACTION: Voted "Do Pass" by the Standing Committee on Transportation by a vote of 8 to 3. Voted "Do Pass" by the Select Committee on State and Local Governments by a vote of 6 to 1.

Currently, an individual operating or riding as a passenger on any motorcycle or motortricycle upon any state highway must wear protective headgear when the vehicle is in motion. This bill specifies that this provision will not apply to an individual 21 years of age or older, unless he or she has only been issued an instruction permit if he or she maintains proof of financial responsibility of at least \$50,000 of personal medical insurance.

PROPONENTS: Supporters say that the decision to wear a helmet should be decided by consenting adults. The bill will bring Missouri into line with many of its bordering states. There will be little medical cost from accidents because riders are required to purchase personal medical insurance. It will increase tourism because motorcyclists will stop avoiding Missouri in order to ride without a helmet.

OPPONENTS: Those who oppose the bill say evidence from other states show that many more people will be killed due to not wearing their helmets. The threat to human life outweighs people's freedom to choose whether or not to wear a helmet. Medical costs relating to head injuries due to not wearing a helmet easily exceed the \$50,000 insurance requirement.
