

HB 649 -- DEPENDENCY EXEMPTION FOR STILLBORN CHILDREN

SPONSOR: Cornejo

Beginning January 1, 2015, this bill authorizes an income tax dependency exemption deduction to a taxpayer for the taxable year in which a stillborn child was born if the child would otherwise have been a member of the taxpayer's household and a certificate of birth resulting in stillbirth has been issued.
