24 "105.485. 1. Each financial interest statement required by sections 105.483 to 105.492 shall
25 be on a form prescribed by the commission and shall be signed and verified by a written declaration
26 that it is made under penalties of perjury; provided, however, the form shall not seek information
27 which is not specifically required by sections 105.483 to 105.492.

29 2. Each person required to file a financial interest statement pursuant to subdivisions (1) to
30 (12) of section 105.483 shall file the following information for himself, his spouse and dependent
31 children at any time during the period covered by the statement, whether singularly or collectively;
32 provided, however, that said person, if he does not know and his spouse will not divulge any
33 information required to be reported by this section concerning the financial interest of his spouse,
shall state on his financial interest statement that he has disclosed that information known to him

1 and that his spouse has refused or failed to provide other information upon his bona fide request,
2 and such statement shall be deemed to satisfy the requirements of this section for such financial
3 interest of his spouse; and provided further if the spouse of any person required to file a financial
4 interest statement is also required by section 105.483 to file a financial interest statement, the
5 financial interest statement filed by each need not disclose the financial interest of the other,
6 provided that each financial interest statement shall state that the spouse of the person has filed a
7 separate financial interest statement and the name under which the statement was filed:

8 (1) The name and address of each of the employers of such person from whom income of
9 one thousand dollars or more was received during the year covered by the statement;

10 (2) The name and address of each sole proprietorship which he owned; the name, address
11 and the general nature of the business conducted of each general partnership and joint venture in
12 which he was a partner or participant; the name and address of each partner or coparticipant for each
13 partnership or joint venture unless such names and addresses are filed by the partnership or joint
14 venture with the secretary of state; the name, address and general nature of the business conducted
15 of any closely held corporation or limited partnership in which the person owned ten percent or
16 more of any class of the outstanding stock or limited partners' units; and the name of any publicly
17 traded corporation or limited partnership which is listed on a regulated stock exchange or automated
18 quotation system in which the person owned two percent or more of any class of outstanding stock,
19 limited partnership units or other equity interests;

20 (3) The name and address of any other source not reported pursuant to subdivisions (1) and
21 (2) and subdivisions (4) to (9) of this subsection from which such person received one thousand
22 dollars or more of income during the year covered by the statement, including, but not limited to,
23 any income otherwise required to be reported on any tax return such person is required by law to
24 file; except that only the name of any publicly traded corporation or limited partnership which is
25 listed on a regulated stock exchange or automated quotation system need be reported pursuant to
26 this subdivision;

27 (4) The location by county, the subclassification for property tax assessment purposes, the
28 approximate size and a description of the major improvements and use for each parcel of real
29 property in the state, other than the individual's personal residence, having a fair market value of ten
30 thousand dollars or more in which such person held a vested interest including a leasehold for a
31 term of ten years or longer, and, if the property was transferred during the year covered by the
32 statement, the name and address of the persons furnishing or receiving consideration for such
33 transfer;

34 (5) The name and address of each entity in which such person owned stock, bonds or other
35 equity interest with a value in excess of ten thousand dollars; except that, if the entity is a
36 corporation listed on a regulated stock exchange, only the name of the corporation need be listed;
37 and provided that any member of any board or commission of the state or any political subdivision
38 who does not receive any compensation for his services to the state or political subdivision other
39 than reimbursement for his actual expenses or a per diem allowance as prescribed by law for each
40 day of such service need not report interests in publicly traded corporations or limited partnerships
41 which are listed on a regulated stock exchange or automated quotation system pursuant to this
42 subdivision; and provided further that the provisions of this subdivision shall not require reporting
43 of any interest in any qualified plan or annuity pursuant to the Employees' Retirement Income
44 Security Act;

45 (6) The name and address of each corporation for which such person served in the capacity
46 of a director, officer or receiver;

47 (7) The name and address of each not-for-profit corporation and each association,
48 organization, or union, whether incorporated or not, except not-for-profit corporations formed to

1 provide church services, fraternal organizations or service clubs from which the officer or employee
2 draws no remuneration, in which such person was an officer, director, employee or trustee at any
3 time during the year covered by the statement, and for each such organization, a general description
4 of the nature and purpose of the organization;

5 (8) The name and address of each source from which such person received a gift or gifts, or
6 honorarium or honoraria in excess of two hundred dollars in value per source during the year
7 covered by the statement other than gifts from persons within the third degree of consanguinity or
8 affinity of the person filing the financial interest statement. For the purposes of this section, a "gift"
9 shall not be construed to mean political contributions otherwise required to be reported by law or
10 hospitality such as food, beverages or admissions to social, art, or sporting events or the like, or
11 informational material. For the purposes of this section, a "gift" shall include gifts to or by creditors
12 of the individual for the purpose of cancelling, reducing or otherwise forgiving the indebtedness of
13 the individual to that creditor;

14 (9) The lodging and travel expenses provided by any third person for expenses incurred
15 outside the state of Missouri whether by gift or in relation to the duties of office of such official,
16 except that such statement shall not include travel or lodging expenses:

17 (a) Paid in the ordinary course of business for businesses described in subdivisions (1), (2),
18 (5) and (6) of this subsection which are related to the duties of office of such official; or

19 (b) For which the official may be reimbursed as provided by law; or

20 (c) Paid by persons related by the third degree of consanguinity or affinity to the person
21 filing the statement; or

22 (d) Expenses which are reported by the campaign committee or candidate committee of the
23 person filing the statement pursuant to the provisions of chapter 130; or

24 (e) Paid for purely personal purposes which are not related to the person's official duties by
25 a third person who is not a lobbyist, a lobbyist principal or member, or officer or director of a
26 member, of any association or entity which employs a lobbyist. The statement shall include the
27 name and address of such person who paid the expenses, the date such expenses were incurred, the
28 amount incurred, the location of the travel and lodging, and the nature of the services rendered or
29 reason for the expenses;

30 (10) The assets in any revocable trust of which the individual is the settlor if such assets
31 would otherwise be required to be reported under this section;

32 (11) The name, position and relationship of any relative within the first degree of
33 consanguinity or affinity to any other person who:

34 (a) Is employed by the state of Missouri, by a political subdivision of the state or special
35 district, as defined in section 115.013, of the state of Missouri;

36 (b) Is a lobbyist; or

37 (c) Is a fee agent of the department of revenue;

38 (12) The name and address of each campaign committee, political committee, candidate
39 committee, or continuing committee for which such person or any corporation listed on such
40 person's financial interest statement received payment; and

41 (13) For members of the general assembly or any statewide elected public official, their
42 spouses, and their dependent children, whether any state tax credits were claimed on the member's,
43 spouse's, or dependent child's most recent state income tax return.

44 3. For the purposes of subdivisions (1), (2) and (3) of subsection 2 of this section, an
45 individual shall be deemed to have received a salary from his employer or income from any source
46 at the time when he shall receive a negotiable instrument whether or not payable at a later date and
47 at the time when under the practice of his employer or the terms of an agreement he has earned or is
48 entitled to anything of actual value whether or not delivery of the value is deferred or right to it has

1 vested. The term income as used in this section shall have the same meaning as provided in the
2 Internal Revenue Code of 1986, and amendments thereto, as the same may be or becomes effective,
3 at any time or from time to time for the taxable year, provided that income shall not be considered
4 received or earned for purposes of this section from a partnership or sole proprietorship until such
5 income is converted from business to personal use.

6 4. Each official, officer or employee or candidate of any political subdivision described in
7 subdivision (11) of section 105.483 shall be required to file a financial interest statement as required
8 by subsection 2 of this section, unless the political subdivision biennially adopts an ordinance, order
9 or resolution at an open meeting by September fifteenth of the preceding year, which establishes and
10 makes public its own method of disclosing potential conflicts of interest and substantial interests
11 and therefore excludes the political subdivision or district and its officers and employees from the
12 requirements of subsection 2 of this section. A certified copy of the ordinance, order or resolution
13 shall be sent to the commission within ten days of its adoption. The commission shall assist any
14 political subdivision in developing forms to complete the requirements of this subsection. The
15 ordinance, order or resolution shall contain, at a minimum, the following requirements with respect
16 to disclosure of substantial interests:

17 (1) Disclosure in writing of the following described transactions, if any such transactions
18 were engaged in during the calendar year:

19 (a) For such person, and all persons within the first degree of consanguinity or affinity of
20 such person, the date and the identities of the parties to each transaction with a total value in excess
21 of [five] two hundred fifty dollars, if any, that such person had with the political subdivision, other
22 than compensation received as an employee or payment of any tax, fee or penalty due to the
23 political subdivision, and other than transfers for no consideration to the political subdivision;

24 (b) The date and the identities of the parties to each transaction known to the person with a
25 total value in excess of [five] two hundred fifty dollars, if any, that any business entity in which
26 such person had a substantial interest, had with the political subdivision, other than payment of any
27 tax, fee or penalty due to the political subdivision or transactions involving payment for providing
28 utility service to the political subdivision, and other than transfers for no consideration to the
29 political subdivision;

30 (2) The chief administrative officer and chief purchasing officer of such political
31 subdivision shall disclose in writing the information described in subdivisions (1), (2) and (6) of
32 subsection 2 of this section;

33 (3) Disclosure of such other financial interests applicable to officials, officers and
34 employees of the political subdivision, as may be required by the ordinance or resolution;

35 (4) Duplicate disclosure reports made pursuant to this subsection shall be filed with the
36 commission and the governing body of the political subdivision. The clerk of such governing body
37 shall maintain such disclosure reports available for public inspection and copying during normal
38 business hours."; and"; and
