### FISCAL ANALYSIS

## **ASSUMPTION**

Officials at the **City of St. Louis** assume this proposal would have a potential negative impact on revenues to the City. The City of St. Louis currently does not issue red-light camera tickets. However the proposed legislation would preclude the City from addressing any deficiencies in the previous ordinance and eliminate the possibility of reintroducing this method of public safety traffic enforcement. Previously, the red light traffic light program provided approximately \$3.5 million in net revenue annually.

**Oversight** assumes the Missouri Supreme Court struck down the St. Louis City ordinance governing red light cameras, as well as, language in similar ordinances in Moline Acres and St. Peters according to a news article in the St. Louis Post Dispatch dated August 19, 2015. The article noted the Supreme Court found ordinance 66868 to be unconstitutional because it creates a rebuttable presumption that improperly shifts the burden of persuasion onto the defendant to prove that he or she was not operating the motor vehicle at the time of the violation. Because of this ruling, Oversight assumes no additional revenue will be collected from this proposal on redlight traffic cameras.

Officials at the **Boone County Sheriff's Department** state the Department does not utilize red light cameras. However, this legislation would prohibit the use of the Department's Automated License Plate Readers (LPR). Should the Department lose the ability to continue using LPR systems, the total financial investment loss of the program would be \$241,577.

**Oversight** assumes local law enforcement does not generate revenue from LPR systems, but utilize them to monitor. Therefore, Oversight will not assume an ongoing loss of revenue to local political subdivisions.

Officials at the Office of the State Courts Administrator, the Department of Public Safety's Missouri Highway Patrol, the Missouri Department of Transportation and the Department of Revenue each assume no fiscal impact to their respective agencies from this proposal.

Officials at the City of Kansas City, the St. Louis County Justice Services, the City of Jefferson, the City of Independence and the Springfield Police Department each assume no fiscal impact to their respective entities from this proposal.

### FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

# FISCAL DESCRIPTION

Beginning August 28, 2016, this bill prohibits any county, city, town, village, municipality, state agency, or other political subdivision of this state from enacting, adopting, or enforcing any law, ordinance, regulation, order, or other provision that authorizes the use of an automated traffic system. Any county, city, town, village, municipality, state agency, or other political subdivision that currently has an automated traffic enforcement system installation or maintenance contract with a company or entity on August 28, 2016, must complete or terminate the contract by September 1, 2017. No automatic number plate recognition system can be used for any commercial purpose or be unmanned.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
