FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Corrections (DOC)** state a court may delegate an individual to bring an offender's child to see him/her while incarcerated; however, that individual is still subject to a background check. If the background check indicates the individual is not clear for entry, he/she will not be permitted to bring the child in to visit the offender parent.

In addition, not all offenders are allowed to visit with their children. They may be restricted from visitation due to current or prior offenses of abuse (physical and sexual) against children. Thus, while the court may approve an individual to bring in a child for visitation with a parent, not necessarily will the offender parent be allowed to visit with the child. Should they be allowed to visit with the child, it would need to be during a normal visitation period.

DOC assumes the proposal would not create a fiscal impact.

Officials from the **Department of Social Services** and the **Office of the State Courts Administrator** each assume the proposal would not fiscally impact their respective agencies.
