## FISCAL ANALYSIS

### ASSUMPTION

Officials at the **Office of the Governor, Callaway County, Jackson County Board of Election Commissioners, Buchanan County,** and **Kansas City Board of Election Commissioners** each assume no fiscal impact from this proposal to their respective organizations.

In response to a previous version, officials at the **Office of the Secretary of State, Mississippi County, Platte County Board of Election Commissioners,** and the **St. Louis County Board of Election Commissioners** each assumed no fiscal impact from this proposal to their respective organizations.

**Oversight** assumes the counties may see a savings due to counties appointing vacated county elected officials rather than holding a special election. Oversight will range the fiscal impact as \$0 to Unknown.

Officials at the following boards of election commissioners: St. Louis City Board of Election Commissioners and Clay County Board of Election Commissioners did not respond to **Oversight's** request for fiscal impact.

No direct fiscal impact to small businesses would be expected as a result of this proposal.

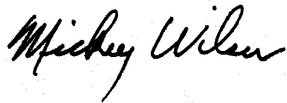
FISCAL DESCRIPTION
