FISCAL ANALYSIS

ASSUMPTION

Oversight notes this proposal would not allow school districts to collect biometric information on any student without the express written consent of the student's parent or guardian. Oversight assumes that this proposal would not have a fiscal impact.

Officials at the **Department of Elementary and Secondary Education** assume there is no fiscal impact from this proposal.

Officials at the **Smithville R-II School District** assume \$20,000 for staff to manage data.

Officials at the **Chilhowee R-IV, Everton, Kansas City, Kearney, Macon County R-IV, Malta Bend, New Haven, Sarcoxie, Shell Knob, St. Elizabeth, Warren County R-III, Webster Groves, West Plains** and the **Wright City R-II** school districts each assume there is no fiscal impact from this proposal to their respective districts.

Officials at the **Concordia School District** responded to Oversight's request for fiscal impact but did not indicate an impact.

The proposed legislation appears to have no direct fiscal impact.

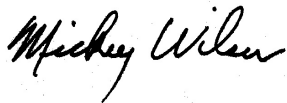
This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
