FISCAL ANALYSIS

ASSUMPTION

Oversight notes this proposal states a student journalist has the right to exercise freedom of speech regardless of whether the media is supported financially by the school district. Certain exceptions are outlined in the proposal. Oversight assumes this would not financially impact the public schools or public higher education institutions.

Officials at the **Department of Higher Education** assume there is no fiscal impact from this proposal.

Officials at the **Missouri Western State University, Missouri State University, Northwest Missouri State University, State Technical College of Missouri** and the **University of Missouri** each assume there is no fiscal impact from this proposal to their respective institutions.

Officials at the **University of Central Missouri** assume this may require them to hire another copy editor at a cost of \$72,000 annually.

Officials at the **Department of Elementary and Secondary Education (DESE)** assume there is no fiscal impact from this proposal on the department. The proposal may have an impact on school districts and DESE defers to the school districts for that impact.

Officials at the **Wright City R-II School District** assume this would not cost the district. However, the libel that could fall on the district for not being able to censor publication that is paid for by tax payer funds could have the potential to be expensive and unknown.

Officials at the **Concordia R-II, East Newton, Everton, Forsyth R-III, Kansas City, Kearney R-I, Kingston 42, Macon County R-IV, Malta Bend, Middle Grove, New Haven, Seymour R-II** and the **Warren County R-III** and the **West Plains** school districts each assume there is no fiscal impact from this proposal to their respective districts.

Officials at the following colleges: Crowder, East Central Community College, Harris-Stowe, Jefferson College, Lincoln University, Metropolitan Community College, Moberly Area Community College, Missouri Southern State University, Southeast Missouri State University, State Fair Community College, St. Charles Community College, St. Louis Community College, Three Rivers Community College and the Truman State University did not respond to **Oversight's** request for fiscal impact.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
