ASSUMPTION

Oversight was unable to receive some of the agency responses in a timely manner due to the short fiscal note request time. Oversight has presented this fiscal note on the best current information that we have or on prior year information regarding a similar bill. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval of the chairperson of the Joint Committee on Legislative Research to publish a new fiscal note.

Oversight assumes this proposal, which changes the application requirements used for licensing land surveyors, will not fiscally impact Department of Insurance, Financial Institutions and Professional Registration.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
