AN ACT

To amend chapter 161, RSMo, by adding thereto four new sections relating to the Missouri parent/teacher involvement act.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 161, RSMo, is amended by adding thereto four new sections, to be
2 known as sections 161.950, 161.952, 161.954, and 161.956, to read as follows:

3 **161.950. 1. The provisions of sections 161.950 to 161.956 shall be known as the**
4 **"Missouri Parent/Teacher Involvement Act". The "Missouri Parent/Teacher Involvement**
5 **Program" is hereby established for the purpose of providing grant awards to schools in**
6 **which a majority of school staff, including administrators, teachers, counselors, and other**
7 **support staff, agree to develop and build trusting relationships with families, thereby**
8 **increasing communication and accountability, with the goal of contributing to the**
9 **academic and social success of pupils. The department of elementary and secondary**
10 **education shall coordinate and administer the program. Priority for distribution of grant**
11 **moneys under the program established under sections 161.950 to 161.956 shall be given to**
12 **districts with Missouri assessment program scores in the lowest twentieth percentile.**

13 **2. Schools within the state that serve any students in kindergarten or any grade not**
14 **higher than grade twelve shall operate parent/teacher involvement programs that meet the**
15 **following requirements:**

14 **(1) At least fifty percent of the staff employed at the school site shall voluntarily**
15 **agree to participate in either periodic visits to the homes of pupils or in community**
16 **meetings that are held at times and locations convenient to parents and legal guardians;**

17 **(2) Prior to the commencement of home visits, a school shall establish a compact**
18 **in which parents and legal guardians agree to participate in periodic home visits or**
19 **community meetings;**

20 **(3) A teacher who participates in the program shall receive training in strategies**
21 **for communicating effectively with parents and legal guardians and in conducting periodic**
22 **home visits or community meetings. These strategies may include providing parents and**
23 **legal guardians with guidance on how to reinforce educational objectives with their**
24 **children at home;**

25 **(4) Teachers, administrators, counselors, and other support staff shall be**
26 **compensated for their participation in home visits or community meetings at an hourly rate**
27 **no less than the hourly rate derived from their regular base salary; and**

28 **(5) All home visits and community meetings under the program shall be conducted**
29 **by a pair or team that includes at least one staff member and, in the case of schools**
30 **maintaining K-5, the classroom teacher of the pupil.**

32 **For purposes of this subsection, the term "community meetings" means periodic public**
33 **meetings between the teacher and the parent or legal guardian held by schools for the**
34 **purpose of strengthening communication between the schools and parents and legal**
35 **guardians for the improvement of pupil academic achievement.**

161.952. 1. Beginning with school year 2017-18, each school board shall adopt a
2 **policy on parental involvement in the schools of the district. The policy shall be designed**
3 **to build consistent and effective communication between the parents and guardians of**
4 **pupils enrolled in the district and the teachers and administrators assigned to the schools**
5 **the pupils attend. The policy shall provide the opportunity for parents and guardians to**
6 **be actively involved in the pupil's education and to be informed of the following:**

7 **(1) The importance of the involvement of parents and guardians in directly**
8 **affecting the success of their children's educational efforts;**

9 **(2) How and when to assist their children or foster children in learning activities**
10 **and support their children's or foster children's classroom learning activities; and**

11 **(3) Techniques, strategies, and skills to use at home to improve their children's**
12 **academic success and to support their children's academic efforts at school and their**
13 **development as future responsible adult members of society.**

14 **2. The state board of education shall adopt recommendations for the development**
15 **of parental involvement policies under this section.**

161.954. 1. There is hereby created in the state treasury the "Missouri
2 **Parent/Teacher Involvement Program Fund", which shall consist of moneys appropriated**
3 **for the program established under section 161.950. The state treasurer shall be custodian**
4 **of the fund. In accordance with sections 30.170 and 30.180, the state treasurer may**
5 **approve disbursements. The fund shall be a dedicated fund and, upon appropriation,**
6 **moneys in the fund shall be used solely for the administration of sections 161.950 to**
7 **161.956.**

8 **2. Notwithstanding the provisions of section 33.080 to the contrary, any moneys**
9 **remaining in the fund at the end of the biennium shall not revert to the credit of the**
10 **general revenue fund.**

11 **3. The state treasurer shall invest moneys in the fund in the same manner as other**
12 **funds are invested. Any interest and moneys earned on such investments shall be credited**
13 **to the fund.**

161.956. Under section 23.253 of the Missouri sunset act:

2 **(1) The provisions of the new program authorized under sections 161.950 to**
3 **161.956 shall automatically sunset six years after the effective date of sections 161.950 to**
4 **161.956 unless reauthorized by an act of the general assembly; and**

5 **(2) If such program is reauthorized, the program authorized under sections 161.950**
6 **to 161.956 shall automatically sunset twelve years after the effective date of the**
7 **reauthorization of sections 161.950 to 161.956; and**

8 **(3) Sections 161.950 to 161.956 shall terminate on September first of the calendar**
9 **year immediately following the calendar year in which the program authorized under**
10 **sections 161.950 to 161.956 is sunset.**
