2 Page 1, Line 12, by inserting after all of said line the following:

4 "Further amend said bill, Page 2, Section 160.400, Line 50, by deleting the phrase "section
5 160.425." on said line and inserting in lieu thereof the following:

7 "section 160.425.

9 No college, university, school, or other entity under this subsection shall be eligible to sponsor a
10 charter school if the entity is currently sponsoring a charter school that has a three year annual
11 performance review lower than that required for accreditation."; and"; and

13 Further amend said amendment and page, Line 15, by inserting after all of said line the following:

15 "Further amend said bill, page, and section, Lines 59 to 61, by deleting all of said lines and inserting
16 in lieu thereof the following:

18 "be made in writing. If the local school board declines to sponsor the charter school of its own
19 vote, it may also submit the question of establishing a charter school in the district to a vote of the
20 people of the school district at the next school board election, but is not required to submit the
21 charter school issue to such a vote of the people. If the school board does submit the issue to a vote
22 and a majority is not in favor of establishing a charter school, then no charter school shall be
23 established under subdivision (3) of subsection 2 of this section for a period of three years. No
24 person, group, or organization seeking to establish a charter"; and"; and

26 Further amend said amendment and page, Lines 25-32, by deleting all of said lines and inserting in
27 lieu thereof the following:

29 ""for a five-year term; except that, if the annual performance report score of a charter school, other
30 than a charter school in which fifty percent or more of the school's students were previously
31 considered dropouts under subdivision (5) of subsection 2 of this section, is below the average of
32 the annual performance report scores of all non-selective grade-level-equivalent school buildings in
33 the school district in which the charter school is located for two of the three consecutive years

1 immediately before a decision whether to renew is made, such renewal shall be for only a three-year
2 term, and if, during such three-year term, the charter school's annual performance report score is
3 below such average for two of the three years, the charter school term shall not be renewed. Any
4 charter school other than a charter school established under subdivision (3) of subsection 2 of
5 section 160.400 that seeks a renewal shall have such renewal put to a vote of the people of the
6 school district in which the charter school is located"; and"; and
