1 AMEND House Committee Bill No. 15, Page 13, Section 195.070, Line 27, by inserting immediately after
2 said section and line the following:

3
4 "195.075. 1. (1) Beginning July 1, 2020, each individual under section 195.070 with prescriptive
5 authority, other than a veterinarian, who has registered to prescribe a controlled substance under the
6 comprehensive drug control act shall complete per licensing period at least four continuing professional
7 education hours in approved classes that provide training in prescribing controlled substances. Such classes
8 shall address ways to minimize the misuse and abuse of controlled substances, as well ways to recognize
9 controlled substance addictions in patients.

10 (2) Any class that provides training in prescribing controlled substances under this section shall:

11 (a) Meet the requirements under 20 CSR 2150-2.125;

12 (b) Be presented by an organization accredited to provide continuing professional education by:

13 a. The Accreditation Council for Continuing Medical Education;

14 b. The Missouri State Medical Association; or

15 c. Another recognized state continuing professional education accrediting body; and

16 (c) Be approved by:

17 a. The recognized state continuing professional education accrediting body; and

18 b. The division of professional registration.

19 2. Classes providing training in prescribing controlled substances required under this section:

20 (1) May be held:

21 (a) In connection with other continuing professional education programs; and

22 (b) Online;

23 (2) Shall not increase the total number of state-required continuing professional education hours
24 required for prescriber licensing; and

25 (3) Shall be reported by an individual as part of the continuing professional education required for
26 licensing."; and

28 Further amend said bill, Page 23, Section 217.364, Line 37, by inserting immediately after said section and
29 line the following:

31 "330.070. 1. The board shall on or before the first day of the month preceding the biennial license
32 renewal date cause to be mailed to each person licensed to practice podiatric medicine in this state, at the last
33 known office or residence address of such person, a blank application form for such person's biennial license
34 renewal.

35 2. Each person applying for biennial license renewal shall complete the form and return it to the
36 board on or before the renewal date for the licensing period for which the person desires to be registered.

37 3. Each applicant shall give on the form such applicant's full name and the applicant's office address.

38 4. Each applicant shall give with the application for biennial license renewal satisfactory evidence of
39 completion of twenty-four hours of postgraduate study, including four hours of approved classes that provide

1 training in prescribing controlled substances as required under section 195.075, for each renewal period since
 2 the last issuance or renewal of the license. The postgraduate study required shall be that presented by a
 3 college of podiatric medicine accredited by the American Podiatric Medical Association or a course of study
 4 approved by the board.

5 5. Failure of the registrant to receive the renewal form shall not relieve any registrant of the duty to
 6 register and pay the fee required by this chapter nor exempt any such person from the penalties provided by
 7 this chapter for failure to register.

8 332.181. 1. No person shall engage in the practice of dentistry in Missouri without having first
 9 secured a license as provided for in this chapter.

10 2. Any person desiring a license to practice dentistry in Missouri shall pay the required fee and make
 11 application to the board on a form prescribed by the board pursuant to section 332.141. An application for
 12 licensure shall be active for one year after the date it is received by the board. The application becomes void
 13 if not completed within such one-year period.

14 3. All persons once licensed to practice dentistry in Missouri shall renew his or her license to
 15 practice dentistry in Missouri on or before the license renewal date and shall display his or her license for
 16 each current licensing period in the office in which he or she practices or offers to practice dentistry.

17 4. Effective with the licensing period beginning on December 1, 2002, a license shall be renewed
 18 every two years. To renew a license, each dentist shall submit satisfactory evidence of completion of fifty
 19 hours of continuing education during the two-year period immediately preceding the renewal period,
 20 including four hours of approved classes that provide training in prescribing controlled substances as
 21 required under section 195.075. Each dentist shall maintain documentation of completion of the required
 22 continuing education hours as provided by rule. Failure to obtain the required continuing education hours,
 23 submit satisfactory evidence, or maintain documentation is a violation of section 332.321. As provided by
 24 rule, the board may waive and/or extend the time requirements for completion of continuing education for
 25 reasons related to health, military service, foreign residency or for other good cause. All requests for waivers
 26 and/or extensions of time shall be made in writing and submitted to the board before the renewal date.

27 5. Any licensed dentist who fails to renew his or her license on or before the renewal date may apply
 28 to the board for renewal of his or her license within four years subsequent to the date of the license
 29 expiration. To renew an expired license, the person shall submit an application for renewal, pay the renewal
 30 fee and renewal penalty fee as set by rule, and submit satisfactory evidence of completion of at least fifty
 31 hours of continuing education for each renewal period that his or her license was expired as provided by rule.
 32 The required hours must be obtained within four years prior to renewal. The license of any dentist who fails
 33 to renew within four years of the time his or her license has expired shall be void. The dentist may apply for
 34 a new license; provided that, unless application is made under section 332.321, the dentist shall pay the same
 35 fees and be examined in the same manner as an original applicant for licensure as a dentist."; and

 37 Further amend said bill, Page 25, Section 334.036, Line 65, by inserting immediately after said line the
 38 following:

 40 "7. Under the requirements of 20 CSR 2150-2.230, the state board of registration for the healing arts
 41 shall accept toward the one hundred-hour continuing medical education requirement, four hours of
 42 continuing medical education classes that provide training in prescribing controlled substances as required
 43 under section 195.075."; and

 45 Further amend said bill and page, Section 334.074, Line 3, by inserting immediately after said section and
 46 line the following:

 48 "334.075. The board shall not renew any certificate of registration unless the licensee shall provide
 49 satisfactory evidence that he or she has complied with the board's minimum requirements for continuing
 50 education, including four hours of approved classes that provide training in prescribing controlled substances
 51 as required under section 195.075. At the discretion of the board, compliance with the provisions of this
 52 section may be waived for licensed physicians who have discontinued their practice of medicine because of
 53 retirement.

1 334.747. 1. A physician assistant with a certificate of controlled substance prescriptive authority as
 2 provided in this section may prescribe any controlled substance listed in Schedule III, IV, or V of section
 3 195.017, and may have restricted authority in Schedule II, when delegated the authority to prescribe
 4 controlled substances in a supervision agreement. Such authority shall be listed on the supervision
 5 verification form on file with the state board of healing arts. The supervising physician shall maintain the
 6 right to limit a specific scheduled drug or scheduled drug category that the physician assistant is permitted to
 7 prescribe. Any limitations shall be listed on the supervision form. Prescriptions for Schedule II medications
 8 prescribed by a physician assistant with authority to prescribe delegated in a supervision agreement are
 9 restricted to only those medications containing hydrocodone. Physician assistants shall not prescribe
 10 controlled substances for themselves or members of their families. Schedule III controlled substances and
 11 Schedule II - hydrocodone prescriptions shall be limited to a five-day supply without refill. Physician
 12 assistants who are authorized to prescribe controlled substances under this section shall register with the
 13 federal Drug Enforcement Administration and the state bureau of narcotics and dangerous drugs, and shall
 14 include the Drug Enforcement Administration registration number on prescriptions for controlled substances.

15 2. The supervising physician shall be responsible to determine and document the completion of at
 16 least one hundred twenty hours in a four-month period by the physician assistant during which the physician
 17 assistant shall practice with the supervising physician on-site prior to prescribing controlled substances when
 18 the supervising physician is not on-site. Such limitation shall not apply to physician assistants of population-
 19 based public health services as defined in 20 CSR 2150-5.100 as of April 30, 2009.

20 3. A physician assistant shall receive a certificate of controlled substance prescriptive authority from
 21 the board of healing arts upon verification of the completion of the following educational requirements:

22 (1) Successful completion of an advanced pharmacology course that includes clinical training in the
 23 prescription of drugs, medicines, and therapeutic devices. A course or courses with advanced
 24 pharmacological content in a physician assistant program accredited by the Accreditation Review
 25 Commission on Education for the Physician Assistant (ARC-PA) or its predecessor agency shall satisfy such
 26 requirement;

27 (2) Completion of a minimum of three hundred clock hours of clinical training by the supervising
 28 physician in the prescription of drugs, medicines, and therapeutic devices;

29 (3) Completion of a minimum of one year of supervised clinical practice or supervised clinical
 30 rotations. One year of clinical rotations in a program accredited by the Accreditation Review Commission
 31 on Education for the Physician Assistant (ARC-PA) or its predecessor agency, which includes
 32 pharmacotherapeutics as a component of its clinical training, shall satisfy such requirement. Proof of such
 33 training shall serve to document experience in the prescribing of drugs, medicines, and therapeutic devices;

34 (4) A physician assistant previously licensed in a jurisdiction where physician assistants are
 35 authorized to prescribe controlled substances may obtain a state bureau of narcotics and dangerous drugs
 36 registration if a supervising physician can attest that the physician assistant has met the requirements of
 37 subdivisions (1) to (3) of this subsection and provides documentation of existing federal Drug Enforcement
 38 Agency registration.

39 4. A physician assistant shall complete four hours of approved classes that provide training in
 40 prescribing controlled substances as required under section 195.075.

41 335.019. 1. The board of nursing may grant a certificate of controlled substance prescriptive
 42 authority to an advanced practice registered nurse who:

43 (1) Submits proof of successful completion of an advanced pharmacology course that shall include
 44 preceptorial experience in the prescription of drugs, medicines and therapeutic devices; ~~and~~

45 (2) Provides documentation of a minimum of three hundred clock hours preceptorial experience in
 46 the prescription of drugs, medicines, and therapeutic devices with a qualified preceptor; ~~and~~

47 (3) Provides evidence of a minimum of one thousand hours of practice in an advanced practice
 48 nursing category prior to application for a certificate of prescriptive authority. The one thousand hours shall
 49 not include clinical hours obtained in the advanced practice nursing education program. The one thousand
 50 hours of practice in an advanced practice nursing category may include transmitting a prescription order
 51 orally or telephonically or to an inpatient medical record from protocols developed in collaboration with and
 52 signed by a licensed physician; and

53 (4) Has a controlled substance prescribing authority delegated in the collaborative practice

1 arrangement under section 334.104 with a physician who has an unrestricted federal Drug Enforcement
2 Administration registration number and who is actively engaged in a practice comparable in scope, specialty,
3 or expertise to that of the advanced practice registered nurse.

4 2. An advanced practice registered nurse shall complete four hours of approved classes that provide
5 training in prescribing controlled substances as required under section 195.075.

6 336.080. 1. Every licensed optometrist who continues in active practice or service shall, on or
7 before the renewal date, renew his or her license and pay the required renewal fee and present satisfactory
8 evidence to the board of his or her attendance for a minimum of thirty-two hours of board-approved
9 continuing education, or their equivalent during the preceding two-year continuing education reporting
10 period as established by rule and regulation. Such continuing education shall include four hours of approved
11 classes that provide training in prescribing controlled substances as required under section 195.075. The
12 continuing education requirement may be waived by the board upon presentation to it of satisfactory
13 evidence of the illness of the optometrist or for other good cause as defined by rule and regulation. The
14 board shall not reject any such application if approved programs are not available within the state of
15 Missouri. Every license which has not been renewed on or before the renewal date shall expire.

16 2. Any licensed optometrist who permits his or her license to expire may renew it within five years
17 of expiration upon payment of the required reactivation fee and presentation of satisfactory evidence to the
18 board of his or her attendance for a minimum of forty-eight hours of board-approved continuing education,
19 or their equivalent, during the five years."; and
