AN ACT

To amend chapter 407, RSMo, by adding thereto one new section relating to the sale of baby crib bumper pads, with penalty provisions and a delayed effective date.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 407, RSMo, is amended by adding thereto one new section, to be known as section 407.780, to read as follows:

407.780. 1. As used in this section, the following terms shall mean:

2 **(1) “Children’s product”, a product including, but not limited to, a crib, toddler**
3 **bed, bed, car seat, chair, high chair, booster chair, bath seat, gate or other enclosure for**
4 **confining a child, play yard, stationary activity center, carrier, stroller, walker, swing, or**
5 **toy or play equipment that is designed or intended for the care of or use by a child;**

6 **(2) “Commercial dealer”, any person who deals in children’s products or crib**
7 **bumper pads or who otherwise by one’s occupation holds oneself out as having knowledge**
8 **or skill relating to children’s products or crib bumper pads or any person who is in the**
9 **business of remanufacturing, retrofitting, selling, leasing, subletting, or otherwise placing**
10 **in the stream of commerce children’s products or crib bumper pads;**

11 **(3) “Crib bumper pad”, a pad or pads of nonmesh material including, but not**
12 **limited to, a roll of stuffed fabric that is designed for placement within a crib to cushion**
13 **one or more of the crib’s inner sides adjacent to the crib mattress. “Crib bumper pad”**
14 **shall not include mesh liners;**

15 **(4) “Distributor” or “wholesaler”, any person other than a manufacturer or retailer**
16 **who sells or resells or otherwise places into the stream of commerce a children’s product**
17 **or crib bumper pad;**

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

18 **(5) “Importer”, any person who brings into this country and places into the stream**
19 **of commerce a children’s product or crib bumper pad;**

20 **(6) “Manufacturer”, any person who makes and places into the stream of**
21 **commerce a children’s product or crib bumper pad;**

22 **(7) “Retailer”, any person other than a manufacturer, distributor, or wholesaler**
23 **who sells, leases, or sublets children’s products or crib bumper pads.**

24 **2. No commercial dealer, manufacturer, importer, distributor, wholesaler, or**
25 **retailer shall sell, lease, offer for sale, or offer for lease in the state any crib bumper pad**
26 **as an accessory to a crib or as a separate item.**

27 **3. Any violation of the provisions of this section shall result in a penalty of not less**
28 **than one hundred dollars nor more than five hundred dollars for each offense.**

 Section B. The enactment of section 407.780 of section A of this act shall become
2 effective on January 1, 2019.
