AN ACT

To repeal section 589.414, RSMo, and to enact in lieu thereof one new section relating to electronic monitoring of certain sexual offenders while relocating.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Section 589.414, RSMo, is repealed and one new section enacted in lieu thereof, to be known as section 589.414, to read as follows:

589.414. 1. Any person required by sections 589.400 to 589.425 to register shall, not later than three business days after each change of name, residence within the county or city not within a county at which the offender is registered, employment, or student status, appear in person to the chief law enforcement officer of the county or city not within a county and inform such officer of all changes in the information required by the offender. The chief law enforcement officer shall immediately forward the registrant changes to the Missouri state highway patrol within three business days.

2. **(1)** If any person required by sections 589.400 to 589.425 to register changes such person's residence or address to a different county or city not within a county, the person shall appear in person and shall inform both the chief law enforcement official with whom the person last registered and the chief law enforcement official of the county or city not within a county having jurisdiction over the new residence or address in writing within three business days of such new address and phone number, if the phone number is also changed. **If any person required by sections 589.400 to 589.425 to register changes such person's residence or address to a different county or city not within a county and such person was convicted of child molestation in the first degree, the person, in addition to the requirements under this subdivision, shall also be required to be electronically monitored while relocating. 18 **the person has relocated to the residence or address in a different county or city not within**
19 **a county, no electronic monitoring shall be required. Such person shall be responsible for**
20 **all costs associated with electronic monitoring.**

21 (2) If any person required by sections 589.400 to 589.425 to register changes [~~their~~] **his**
22 **or her** state of residence, the person shall appear in person and shall inform both the chief law
23 enforcement official with whom the person was last registered and the chief law enforcement
24 official of the area in the new state having jurisdiction over the new residence or address within
25 three business days of such new address.

26 (3) Whenever a registrant changes residence, the chief law enforcement official of the
27 county or city not within a county where the person was previously registered shall inform the
28 Missouri state highway patrol of the change within three business days. When the registrant is
29 changing the residence to a new state, the Missouri state highway patrol shall inform the
30 responsible official in the new state of residence within three business days.

31 3. In addition to the requirements of subsections 1 and 2 of this section, the following
32 offenders shall report in person to the chief law enforcement agency every ninety days to verify
33 the information contained in their statement made pursuant to section 589.407:

34 (1) Any offender registered as a predatory or persistent sexual offender under the
35 definitions found in section 566.125;

36 (2) Any offender who is registered for a crime where the victim was less than eighteen
37 years of age at the time of the offense; and

38 (3) Any offender who has pled guilty or been found guilty pursuant to section 589.425
39 of failing to register or submitting false information when registering.

40 4. In addition to the requirements of subsections 1 and 2 of this section, all registrants
41 shall report semiannually in person in the month of their birth and six months thereafter to the
42 chief law enforcement agency to verify the information contained in their statement made
43 pursuant to section 589.407. All registrants shall allow the chief law enforcement officer to
44 [~~take~~] **deliver** a current photograph of the offender in the month of his or her birth to the chief
45 law enforcement agency.

46 5. In addition to the requirements of subsections 1 and 2 of this section, all Missouri
47 registrants who work or attend school or training on a full-time or part-time basis in any other
48 state shall be required to report in person to the chief law enforcement officer in the area of the
49 state where they work or attend school or training and register in that state. "Part-time" in this
50 subsection means for more than seven days in any twelve-month period.

51 6. If a person, who is required to register as a sexual offender under sections 589.400 to
52 589.425, changes or obtains a new online identifier as defined in section 43.651, the person shall

53 report such information in the same manner as a change of residence before using such online
54 identifier.
