

HB 2638 -- CORPORATE INCOME TAX

SPONSOR: Smith (163)

This bill changes the calculation of taxable income of corporations by disallowing any intercompany transactions between corporations that file a consolidated income tax return in this state to be considered sales and business transactions in determining taxable income in Missouri.
