AN ACT

To repeal sections 188.010, 188.015, 188.020, 188.021, 188.023, 188.025, 188.027, 188.028, 188.030, 188.031, 188.035, 188.036, 188.037, 188.039, 188.043, 188.047, 188.052, 188.055, 188.060, 188.065, 188.070, 188.075, 188.080, 188.085, 188.100, 188.105, 188.110, 188.115, 188.120, 188.125, 188.130, 188.160, 188.200, 188.205, 188.210, 188.215, 188.220, 188.230, 188.250, 188.325, 188.335, 197.032, 197.200, 197.315, and 565.300, RSMo, and to enact in lieu thereof four new sections relating to abortion, with penalty provisions.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Sections 188.010, 188.015, 188.020, 188.021, 188.023, 188.025, 188.027, 188.028, 188.030, 188.031, 188.035, 188.036, 188.037, 188.039, 188.043, 188.047, 188.052, 188.055, 188.060, 188.065, 188.070, 188.075, 188.080, 188.085, 188.100, 188.105, 188.110, 188.115, 188.120, 188.125, 188.130, 188.160, 188.200, 188.205, 188.210, 188.215, 188.220, 188.230, 188.250, 188.325, 188.335, 197.032, 197.200, 197.315, and 565.300, RSMo, are repealed and four new sections enacted in lieu thereof, to be known as sections 188.016, 197.200, 197.315, and 565.300, to read as follows:

188.016. No person in this state shall perform, procure, or attempt to perform an abortion. Any individual who violates the provisions of this section shall be guilty of the offense of murder in the first degree and shall be punished in accordance with the penalties for that offense under the laws in effect on the effective date of this section.

197.200. As used in sections 197.200 to 197.240, unless the context clearly indicates otherwise, the following terms mean:

(1) [~~“Abortion facility”, as such term is defined in section 188.015;~~

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

4 ~~——(2)]~~ “Ambulatory surgical center”, any public or private establishment operated primarily
5 for the purpose of performing surgical procedures or primarily for the purpose of performing
6 childbirths, and which does not provide services or other accommodations for patients to stay
7 more than twenty-three hours within the establishment, provided, however, that nothing in this
8 definition shall be construed to include the offices of dentists currently licensed pursuant to
9 chapter 332;

10 ~~[(3)]~~ (2) “Dentist”, any person currently licensed to practice dentistry pursuant to chapter
11 332;

12 ~~[(4)]~~ (3) “Department”, the department of health and senior services;

13 ~~[(5)]~~ (4) “Governmental unit”, any city, county or other political subdivision of this state,
14 or any department, division, board or other agency of any political subdivision of this state;

15 ~~[(6)]~~ (5) “Person”, any individual, firm, partnership, corporation, company, or
16 association and the legal successors thereof;

17 ~~[(7)]~~ (6) “Physician”, any person currently licensed to practice medicine pursuant to
18 chapter 334;

19 ~~[(8)]~~ (7) “Podiatrist”, any person currently licensed to practice podiatry pursuant to
20 chapter 330.

197.315. 1. Any person who proposes to develop or offer a new institutional health
2 service within the state must obtain a certificate of need from the committee prior to the time
3 such services are offered.

4 2. Only those new institutional health services which are found by the committee to be
5 needed shall be granted a certificate of need. Only those new institutional health services which
6 are granted certificates of need shall be offered or developed within the state. No expenditures
7 for new institutional health services in excess of the applicable expenditure minimum shall be
8 made by any person unless a certificate of need has been granted.

9 3. After October 1, 1980, no state agency charged by statute to license or certify health
10 care facilities shall issue a license to or certify any such facility, or distinct part of such facility,
11 that is developed without obtaining a certificate of need.

12 4. If any person proposes to develop any new institutional health care service without
13 a certificate of need as required by sections 197.300 to 197.366, the committee shall notify the
14 attorney general, and he shall apply for an injunction or other appropriate legal action in any
15 court of this state against that person.

16 5. After October 1, 1980, no agency of state government may appropriate or grant funds
17 to or make payment of any funds to any person or health care facility which has not first obtained
18 every certificate of need required pursuant to sections 197.300 to 197.366.

19 6. A certificate of need shall be issued only for the premises and persons named in the
20 application and is not transferable except by consent of the committee.

21 7. Project cost increases, due to changes in the project application as approved or due
22 to project change orders, exceeding the initial estimate by more than ten percent shall not be
23 incurred without consent of the committee.

24 8. Periodic reports to the committee shall be required of any applicant who has been
25 granted a certificate of need until the project has been completed. The committee may order the
26 forfeiture of the certificate of need upon failure of the applicant to file any such report.

27 9. A certificate of need shall be subject to forfeiture for failure to incur a capital
28 expenditure on any approved project within six months after the date of the order. The applicant
29 may request an extension from the committee of not more than six additional months based upon
30 substantial expenditure made.

31 10. Each application for a certificate of need must be accompanied by an application fee.
32 The time of filing commences with the receipt of the application and the application fee. The
33 application fee is one thousand dollars, or one-tenth of one percent of the total cost of the
34 proposed project, whichever is greater. All application fees shall be deposited in the state
35 treasury. Because of the loss of federal funds, the general assembly will appropriate funds to the
36 Missouri health facilities review committee.

37 11. In determining whether a certificate of need should be granted, no consideration shall
38 be given to the facilities or equipment of any other health care facility located more than a
39 fifteen-mile radius from the applying facility.

40 12. When a nursing facility shifts from a skilled to an intermediate level of nursing care,
41 it may return to the higher level of care if it meets the licensure requirements, without obtaining
42 a certificate of need.

43 13. ~~[In no event shall a certificate of need be denied because the applicant refuses to
44 provide abortion services or information.]~~

45 ~~14.]~~ 14. A certificate of need shall not be required for the transfer of ownership of an
46 existing and operational health facility in its entirety.

47 ~~[15.]~~ 14. A certificate of need may be granted to a facility for an expansion, an addition
48 of services, a new institutional service, or for a new hospital facility which provides for
49 something less than that which was sought in the application.

50 ~~[16.]~~ 15. The provisions of this section shall not apply to facilities operated by the state,
51 and appropriation of funds to such facilities by the general assembly shall be deemed in
52 compliance with this section, and such facilities shall be deemed to have received an appropriate
53 certificate of need without payment of any fee or charge. The provisions of this subsection shall

54 not apply to hospitals operated by the state and licensed under this chapter, except for department
55 of mental health state-operated psychiatric hospitals.

56 ~~[17.]~~ **16.** Notwithstanding other provisions of this section, a certificate of need may be
57 issued after July 1, 1983, for an intermediate care facility operated exclusively for the
58 intellectually disabled.

59 ~~[18.]~~ **17.** To assure the safe, appropriate, and cost-effective transfer of new medical
60 technology throughout the state, a certificate of need shall not be required for the purchase and
61 operation of:

62 (1) Research equipment that is to be used in a clinical trial that has received written
63 approval from a duly constituted institutional review board of an accredited school of medicine
64 or osteopathy located in Missouri to establish its safety and efficacy and does not increase the
65 bed complement of the institution in which the equipment is to be located. After the clinical trial
66 has been completed, a certificate of need must be obtained for continued use in such facility; or

67 (2) Equipment that is to be used by an academic health center operated by the state in
68 furtherance of its research or teaching missions.

565.300. 1. This section shall be known and may be cited as the "Infant's Protection
2 Act".

3 2. As used in this section, and only in this section, the following terms shall mean:

4 (1) "Born", complete separation of an intact child from the mother regardless of whether
5 the umbilical cord is cut or the placenta detached;

6 (2) "Living infant", a human child, born or partially born, who is alive, as determined
7 in accordance with the usual and customary standards of medical practice and is not dead as
8 determined pursuant to section 194.005, relating to the determination of the occurrence of death,
9 and has not attained the age of thirty days post birth;

10 (3) "Partially born", partial separation of a child from the mother with the child's head
11 intact with the torso. If vaginally delivered, a child is partially separated from the mother when
12 the head in a cephalic presentation, or any part of the torso above the navel in a breech
13 presentation, is outside the mother's external cervical os. If delivered abdominally, a child is
14 partially separated from the mother when the child's head in a cephalic presentation, or any part
15 of the torso above the navel in a breech presentation, is outside the mother's external abdominal
16 wall.

17 3. A person commits the offense of infanticide if he or she causes the death of a living
18 infant with the purpose to cause said death by an overt act performed when the infant is partially
19 born or born.

20 4. The offense of infanticide is a class A felony.

21 5. A physician using procedures consistent with the usual and customary standards of
 22 medical practice to save the life of the mother during pregnancy or birth or to save the life of any
 23 unborn or partially born child of the same pregnancy shall not be criminally responsible under
 24 this section. In no event shall the mother be criminally responsible pursuant to this section for
 25 the acts of the physician if the physician is not held criminally responsible pursuant to this
 26 section.

27 ~~6. [This section shall not apply to any person who performs or attempts to perform a~~
 28 ~~legal abortion if the act that causes the death is performed prior to the child being partially born,~~
 29 ~~even though the death of the child occurs as a result of the abortion after the child is partially~~
 30 ~~born.]~~

31 ~~7.]~~ Only that person who performs the overt act required under subsection 3 of this
 32 section shall be culpable under this section, unless a person, with the purpose of committing
 33 infanticide, does any act which is a substantial step towards the commission of the offense which
 34 results in the death of the living infant. A "substantial step" is conduct which is strongly
 35 corroborative of the firmness of the actor's purpose to complete the commission of the offense.

 37 available to any person under the law including defenses provided pursuant to chapters 562 and
 38 563.

~~[188.010. It is the intention of the general assembly of the state of~~
 2 ~~Missouri to grant the right to life to all humans, born and unborn, and to regulate~~
 3 ~~abortion to the full extent permitted by the Constitution of the United States,~~
 4 ~~decisions of the United States Supreme Court, and federal statutes.]~~

~~[188.015. As used in this chapter, the following terms mean:~~

- 3 ~~(a) The act of using or prescribing any instrument, device, medicine,~~
 4 ~~drug, or any other means or substance with the intent to destroy the life of an~~

3 ~~physician.]~~

2 ~~[188.021. 1. When RU-486 (mifepristone) or any drug or chemical is~~
3 ~~used for the purpose of inducing an abortion, the initial dose of the drug or~~
4 ~~chemical shall be administered in the same room and in the physical presence of~~
5 ~~the physician who prescribed, dispensed, or otherwise provided the drug or~~
6 ~~chemical to the patient. The physician inducing the abortion, or a person acting~~
7 ~~on such physician's behalf, shall make all reasonable efforts to ensure that the~~
8 ~~patient returns after the administration or use of RU-486 or any drug or chemical~~
9 ~~for a follow-up visit unless such termination of the pregnancy has already been~~
10 ~~confirmed and the patient's medical condition has been assessed by a licensed~~
11 ~~physician prior to discharge.~~

12 ~~2. When the Food and Drug Administration label of any drug or chemical~~

 6 ~~sexual abuse, including rape in the first or second degree, or incest, shall be~~

 4 ~~consent, given freely and without coercion. Consent to an abortion is voluntary~~
 5 ~~and informed and given freely and without coercion if, and only if, at least~~
 6 ~~seventy-two hours prior to the abortion:~~

7 ~~(1) The physician who is to perform or induce the abortion, a qualified~~
 8 ~~professional, or the referring physician has informed the woman orally, reduced~~

67 including telephone numbers and, if available, website addresses. Should the

72 active ultrasound image is of a quality consistent with standard medical practice
73 in the community, contains the dimensions of the unborn child, and accurately
74 portrays the presence of external members and internal organs, if present or
75 viewable, of the unborn child. The auscultation of fetal heart tone must also be
76 of a quality consistent with standard medical practice in the community. If the
77 woman chooses to view the ultrasound or hear the heartbeat or both at the
78 abortion facility, the viewing or hearing or both shall be provided to her at the
79 abortion facility at least seventy-two hours prior to the abortion being performed
80 or induced;

The alternatives to abortion public awareness program shall include the development and promotion of a website which provides a geographically indexed list of alternatives to abortion agencies as well as contractors for the alternatives to abortion services program established in section 188.325. As used in this section, "alternatives to abortion agencies" means agencies exempt from income taxation pursuant to the United States Internal Revenue Code that offer alternatives to abortion services as defined within section 188.325, including but not limited to maternity homes, pregnancy resource centers, and agencies commonly known and referred to as crisis pregnancy centers. The alternatives to abortion public awareness program may also include but need not be limited to the use of television, radio, outdoor advertising, newspapers, magazines, and other print media, and the internet to provide information on these alternatives to abortion agencies and services. The state agency or agencies administering the alternatives to abortion public awareness program are encouraged to give first preference to contracting with private agencies or entities, which are exempt from income taxation pursuant to the United States Internal Revenue Code, to conduct the alternatives to abortion public awareness program. Contractors for the alternatives to abortion public awareness program may also be contractors for the alternatives to abortion services program established in section 188.325.—~~
