1 AMEND House Bill No. 1330, Page 5, Section 2, Line 75, by inserting after all of said section the
2 following:

4 "Section 3.1. The director of the department of natural resources shall, at public auction or
5 private sale, sell, transfer, grant, convey, remise, release and forever quitclaim to all interest of the
6 state of Missouri in property located in Oregon County, Missouri, more particularly described as
7 follows:

8 TRACT 1:

9 TOWNSHIP 22 NORTH, RANGE 2 WEST:

10 Section 3: All that part lying West of, or right bank of, the Eleven Point River;

11 Section 4: All that part of the East Half lying West of, or right bank of, the Eleven
12 Point River; All of Lot 1 of the NW1/4;

13 Section 5: All of Lot 1 of the NE1/4; All of Lots 1 and 2 of the NW1/4; All that part
14 of the E1/2 of Lot 3 of the NW1/4 of Section 5 which lies South and West of
15 Billmore Hollow, EXCEPT therefrom that part lying north of Hwy "Y"; All of the
16 W1/2 of Lot 3 of the NW1/4;

17 Section 6: All of the E1/2 of Lots 2 and 3 of the NE1/4;

23 PARCEL I:

24 An easement for ingress and egress over and across an existing private road, 50 feet
25 in width, running Southeasterly from Highway "Y" to a point near the South line of
26 Section 32, Township 23, Range 2, and thence East along the South line of Sections
27 32 and 33, in Township 23, Range 2 to the West line of the above described property.

 6 Section 5 as shown in Plat Book 8 at Page 21 of the records of Oregon County,
 7 Missouri; All of the Southwest Quarter of the Southeast Quarter; All of the
 8 Southwest Quarter;

9 Section 7: All of the East Half of the Northeast Quarter; Block 1 of J. F. Melton
 10 Subdivision of the SW1/4 of the NE1/4 of Section 7 as shown in Plat Book 6 at Page
 11 5 of the records of Oregon County, Missouri; All of the Northwest Quarter of the
 12 Northeast Quarter;

13 Section 8: Block 5 in S. D. Melton's Subdivision of the NE1/4 of the NE1/4 of
 14 Section 8 as shown in Plat Book 7 at Page 16 of the records of Oregon County,
 15 Missouri; Lot 2 Block 1 in S. D. Melton's Subdivision of the SW1/4 of the NE1/4 of
 16 Section 8 as shown in Plat Book 7 at Page 16 of the records of Oregon County,
 17 Missouri; All of the Northwest Quarter of the Northeast Quarter; All of Block 1 in G.
 18 T. Thomasson and wife's Subdivision of the NE1/4 of the SW1/4 of Section 8 as
 19 shown in Plat Book 6 at Page 38 of the Records of Oregon County, Missouri; All of
 20 Lot 1 of Block 1 in G. T. Thomasson and wife's former Subdivision of the NW1/4 of
 21 the SW1/4 of Section 8 as shown in Plat Book 7 at Page 17 of the Records of Oregon
 22 County, Missouri; All of the Northwest Quarter.

23 2. The property described in subsection 1 of this section shall not be used as a park,
 24 as the term is defined in section 253.010.

25 3. The property described in subsection 1 of this section shall first be offered for sale to the
 26 grantor of the property that granted such property to the department of natural resources and
 27 dedicated such property for public use, with such grantor having the right of first refusal. The
 28 grantor shall be offered the ability to repurchase such property at eighty percent of the property's fair
 29 market value. Such grantor shall have thirty calendar days to respond and accept such offer by the
 30 department of natural resources. If the grantor does not respond and accept such offer within thirty
 31 calendar days, the department may offer the property for sale at public auction or to any third party
 32 without the condition that such property be dedicated to public use, but shall not sell such property
 33 for less than eighty percent of the property's fair market value.

34 4. The commissioner of administration may set the terms and conditions for the conveyance
 35 as the commissioner deems reasonable so long as such terms do not conflict with the requirements
 36 of subsection 1 of this section. The property described under subsection 1 of this section may be
 37 subdivided and sold in parcels of not less than three hundred acres.

38 5. The attorney general shall approve the form of the instrument of conveyance.

39 6. The property described under subsection 1 of this section shall be sold, transferred,
 40 granted, conveyed, remitted, released and forever quitclaimed by the director of the department of
 41 natural resources by December 31, 2020.

42 Section 4. 1. The director of the department of natural resources shall, at public auction or
 43 private sale, sell, transfer, grant, convey, remise, release and forever quitclaim to all interest of the
 44 state of Missouri in property located in Oregon County, Missouri, more particularly described as
 45 follows:
